#### ORDER OF BUSINESS

## 1. Call to Order

Chairman Nolan called the meeting to order at 1:00 p.m.

2. Roll Call

- 3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

Ed Reiskin, Director of Transportation discussed the Sunset Tunnel Improvement project and upgrades along the N Judah route.

8. Citizens' Advisory Council Report

9. Public Comment

Bob Cassinelli discussed a taxi booking app. Yellow Cab couldn't find an app that worked for them so they created their own. Their app works great and is being used by more and more passengers each week. There isn't a problem with getting orders via an app. Both Luxor and Town Taxi have an app. Third party apps offer options for those who don't have an app. Having a common app would be an additional burden. He suggested that the SFMTA let customers decide which app they want to use.

Maryta Piazza discussed the wheelchair spaces onboard Muni vehicles. People stand or sit on the lip of the seat and thus are more likely to be thrown forward in the event of an incident. There's nothing to hold onto and so passengers are safer sitting in those seats.

Herbert Weiner expressed concern about ride share companies as they are not insured. Germany has banned these services. He challenged the Board to make a formal declaration to never use these services and to be opposed to them. These ride share cars are dangerous and are a menace to the public. He knows that rideshare cars are backed by Silicon Valley money but the Board represents the public interest.

- A. ESTABLISH BIKE LANE Geneva Ave., westbound, between Cielito Dr. and Esquina Dr.
- B. ESTABLISH TOW-AWAY NO STOPPING ANYTIME Dewey Boulevard, north side, from 77 feet to 125 feet west of Laguna Honda Boulevard.
- C. RESCIND PERPENDICULAR PARKING Rhode Island Street, west side, from 19 feet to 39 feet north of 19th Street.
- D. ESTABLISH RESIDENTIAL PERMIT PARKING AREA S, 2-HOUR PARKING 8 AM TO 9 PM, MONDAY THROUGH FRIDAY – Clover Street, both sides, between 18th Street and Caselli Avenue.
- E. ESTABLISH TOW-AWAY NO PARKING ANYTIME Vesta Street, east side, from Williams Avenue to 48 feet northerly.
- F. ESTABLISH BLUE ZONE 300 South Van Ness Avenue, west side, from 12 feet to 30 feet south of 14th Street.
- G. ESTABLISH BLUE ZONE 1600 Palou Avenue, north side, from 20 feet to 40 feet west of 3rd Street.
- H. REVOKE BLUE ZONE 2424 Clement Street, north side, from 90 feet to 102 feet west of 25th Avenue.
- I. ESTABLISH BLUE ZONE 2400 Clement Street, north side, from 30 feet to 42 feet west of 25th Avenue.
- J. RESCIND TOW-AWAY NO STOPPING ANYTIME 10th Street, east side, from 18 feet to 84 feet south at Stevenson Street.
- K. ESTABLISH NO PARKING ANY TIME 6th Street, east side from Howard Street to 28 feet northerly.
- L. ESTABLISH TOW-AWAY NO PARKING, 8:00 AM TO 9:30 AM, 2:00 PM TO 4:00 PM, SCHOOL DAYS – Aptos Avenue, east side, from 16 feet to 369 feet north of Ocean Avenue. (Explanatory documents include a staff report and resolution. The proposed action is an Approval Action as defined by S.F. Administrative Code Chapter 31.)

- C. ESTABLISH TOW-AWAY NO PARKING ANYTIME -Bay Street, south side, from Fillmore Street to 80 feet easterly
- D. ESTABLISH PARALLEL PARKING -Bay Street, south side, from 80 feet to 163 feet east of Fillmore Street (83 feet) and Bay Street, north side, from 30 feet to 63 feet east of Fillmore Street (33 feet)

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
