BRIEF DESCRIPTION:

Approving various routine traffic and parking modifications.

SUMMARY:

- The SFMTA Board of Directors has authority to adopt parking and traffic regulations changes.
- Taxis are not exempt from any of these regulations.
- Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit and/or result in more than a negligible increase in the use of the street and/or Class 1(c)(13) installation, modification and replacement of traffic signals, where no more than a negligible increase in the use of the street will result.
- The proposed action is an Approval Action as defined by the S. F. Administrative Code Chapter 31.

- N. ESTABLISH OVERSIZE VEHICLE RESTRICTION (NO PARKING, MIDNIGHT TO 6 AM, DAILY, FOR VEHICLES MORE THAN SEVEN FEET TALL OR 22 FEET LONG)
 – Davidson Avenue, south side, between Quint Street and Rankin Street; Evans Avenue, north side, between Quint Street and Rankin Street; Quint Street, west side, between Davidson Avenue and Evans Avenue; and Rankin Street, east side, between Davidson Avenue and Evans Avenue.
- O. ESTABLISH RESIDENTIAL PERMIT PARKING AREA S, 2-HR PARKING, 8 AM TO 9 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA S PERMIT Webster Street, east side, between Fell Street and Oak Street (400 block).
- P. ESTABLISH RESIDENTIAL PERMIT PARKING AREA X, 2-HR PARKING, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA X PERMIT –Mississippi Street, both sides, between 19th Street and 20th Street (400 block).
- Q. ESTABLISH RESIDENTIAL PERMIT PARKING, AREA D, 4-HOUR PARKING, 9 AM TO 5 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA D PERMITS – Marsily Street, from Bosworth Street to St. Mary's Avenue, 01 – 99 (unit block); and Bosworth Street, from Cuvier Street to Marsily Street, north side only (100 block).

- R. RESCIND 35 MILES PER HOUR SPEED LIMIT Persia Avenue between Sunnydale Avenue and easterly terminus at Mansell Street.
- S. ESTABLISH 15 MILES PER HOUR SPEED LIMIT WHEN CHILDREN ARE PRESENT – Persia Avenue, between Dublin Street and easterly terminus at Mansell Street.
- T. ESTABLISH NO RIGHT TURN ON RED Carmel Street, eastbound, at Twin Peaks Boulevard.
- U. ESTABLISH LEFT LANE MUST TURN LEFT Gilman Avenue, westbound, at 3rd Street.
- V. ESTABLISH NO U-TURN Great Highway, northbound, at John F. Kennedy Drive; Great Highway, northbound, at Lincoln Way; Lake Merced Boulevard, northbound, at South State Drive; and Lake Merced Boulevard, northbound, at Higuera Avenue.
- W. ESTABLISH NO TURN ON RED Washington Street, westbound, at Powell Street.
- X. RESCIND NO LEFT TURN Crossover Drive, northbound, at Fulton Street.
- Y. ESTABLISH TOW-AWAY NO STOPPING ANYTIME 15th Street, north side, from Guerrero Street to 60 feet westerly (extends existing 25-foot red zone, removes 1 parking space).
- Z. ESTABLISH NO PARKING ANY TIME 25th Avenue, east side, from Irving Street to 26 feet southerly (6-foot bulb); Irving Street, south side, from 25th Avenue to 25 feet easterly (15-foot bulb); Irving Street, south side, from 22nd Avenue to 28 feet westerly (15-foot bulb); Irving Street, south side, from 22nd Avenue to 37 feet easterly (15-foot bulb); Irving Street, north side, from 22nd Avenue to 33 feet westerly (6-foot bulb); 22nd Avenue, east side, from Irving Street to 26 feet southerly (6-foot bulb); 22nd Avenue, west side, from Irving Street to 22 feet southerly (6-foot bulb); 22nd Avenue, west side, from Irving Street to 28 feet northerly (6-foot bulb); 22nd Avenue, west side, from Irving Street to 28 feet northerly (6-foot bulb); Irving Street, south side, from 20th Avenue to 25 feet easterly (15-foot bulb); Irving Street, south side, from 20th Avenue to 25 feet (6-foot bulb); and Irving Street, north side, from 22nd Avenue to 21 feet easterly (6-foot bulb).
