Steve Ferrario stated that crosswalk audio pedestrian buttons, which when pressed lets a person know their location, do not work. Mr. Ferrario would like to know who is responsible for fixing them, specifically the person/department that is responsible for this.

Steve Ferrario stated that transit shelter audio buttons, which when pressed lets a person know when the next train is arriving, do not work, except for the transit shelter audio button at Folsom & Embarcadero. Mr. Ferrario would like to know who is responsible for repairing these audio buttons; how many are not functioning; and when will they be fixed.
