### STATUS OF MAJOR PROJECTS

- Medallion Permits: 11 total permits were issued during the month of January. 6 transferable permits were sold, 2 non-transferable permits were issued to drivers at the top of the waiting list, and 3 non-transferable ramp permits were issued to drivers at the top of the waiting list.
- Taxi Advisory Council: TAC meetings were held on January 9, and January 30, 2012. At those meetings
  there was a continued discussion regarding alternative plans to the current medallion sales pilot
  program.
- Illegal Vehicle Enforcement. During the month of January, taxi investigators issued five citations to 'bandit' cabs for operating without a permit, as well as one limousine acting illegally as a taxi.
- **Field Enforcement:** During the month of January Taxi Investigator Eric Richholt conducted daily field enforcement, including issuing 35 white zone citations for illegally parked limousines. As part of the day-to-day field enforcement, five citations against color schemes were issued. The SFPD also sent 16 administrative citations to taxicab A-Card permit holders who had been cited by the Police Department for operating limousines illegally like taxicabs.
- **Electric Fast Charging Stations:** Initial installation of fast charging facilities is delayed by the lack of standardized specifications in the industry. Taxi Services met with the Department of Environment regarding the technology and changes on the horizon, as well as potential locations for the stations. Another larger meeting is scheduled for January 30, which will include staff from SFO, the Department of Environment, and the Bay Area Air Quality Management District. This collaborative meeting is expected to generate some positive ideas regarding location of the fast charging stations, as well as potential partnerships that can strengthen the effectiveness of this project.
- **A-Card Renewal:** A-Card Renewal has continued at a steady pace. So far over 5,000 renewals have been processed. The grace period for renewal officially ends on January 31, 2012, but Taxi Services expects approximately 1,000 more renewal requests to trickle in throughout February.
- Clean Fleet: Staff has been working with Planning and the Department of the Environment to calculate the carbon savings that have resulted from the 2006 Clean Taxi ordinance, through which all but 15% of the fleet has converted to an alternative fuel vehicle (hybrid or compressed natural gas), in anticipation of a press event on February 8.
- **Security Cameras**: Staff is working actively with the Taxi & Paratransit Association of California and the Cities of Los Angeles and San Diego to seek amendment of the California Vehicle Code provision that regulates security cameras in taxicabs.

## **DIRECTOR OF TRANSPORTATION – Assistance Required**

Taxi Services continues to operate in a context of innovation and change. It has led to some very exciting developments of which we are very proud, but having to constantly invent and adapt is more resource intensive than having a routine.

For example we are in the midst of ongoing regulatory reform which we have been unable to conclude for lack of resources. Currently the Deputy Director is the only resource available for all analytical work, outreach, legislative matters and complex drafting that is required for regulatory reform. We hope that the best practices consultant will provide the human resources necessary to finally complete review of all of the regulations that need attention, but in the long term this team could use some additional analytical support.

We are also just beginning to get resources into the field, which has been extremely productive. In nine months, a single investigator has issued over \$130,000 worth of citations-more than enough to cover both his salary and overhead. However, our field enforcement efforts and investigations are hampered by having too few investigators. It makes it difficult for investigators to go out in pairs as our field procedures require, so management has had to step in to cover some night shifts. Medallion qualification is slowing down and major investigations have to wait for resources.

We have requested additional positions in the next budget cycle, including Taxi Investigators and an analyst. Further Taxi Investigator hiring is on hold waiting for the Department of Human Resources to re-open the eligible list. Any assistance that could be provided to expedite that process would be helpful.
