PUBLIC COMMENT

Ms. Agguire stated that she would like that during the construction period more lanes of traffic open for bicycles and cars.

Mr. Winston stated that the Board of Supervisors should be asked for funds to redo Ocean Avenue streetscape.

Resident (not identified) inquired if the sidewalks around Lick Wilmerding would be wider after the construction is completed.

David Pilpel thanked Lick Wilmerding for coming and being involved.

4. Informational Presentation on I-280 Interchange Modifications at Balboa Park Project, Michael Tam, SFCTA (20 minutes)

PUBLIC COMMENT

Jennifer stated there is still an underpass exit at Geneva Avenue and inquired if there would be any changes to the off ramp.

Tom Standing stated there might be pedestrian conflicts mostly during the day. He stated that a pedestrian activated signal be installed along with a flashing beacon.

Mr. Winston stated that more pedestrians will be walking on Ocean Avenue in the near future and he was glad to see that changes will happen.

Ms. Agguire inquired as to if the signals would be coordinated with Geneva Avenue.

Jennifer inquired if the schedule of improvements be coordinated with the build out of the Balboa Park Reservoir.

David Pilpel stated that it makes sense for SFCTA is the lead agency with Caltrans the approving body. He inquired about funding and if Caltrans would be conducting any outreach meetings on the project. He stated that he was concerned about Element 1 and that he was looking for information to come out of the Circulation Study.

5. Informational Presentation on Balboa Park Station Eastside and Balboa Park Modernization, Tim Chan, BART, (20 minutes)

Ms. Agguire inquired about the number of elevators and their locations.

David Pilpel stated that he was encouraged and stated that there were actually three plaza areas – Kiss and Ride, Geneva and I-280 and Muni East Side Access.
