5. Presentation, discussion and possible action regarding the Controller's quarterly report on the Public Outreach Rapid Improvement Event. (Explanatory documents include a slide presentation.)

Jessie Rubin, Project Manager, Kyra Sikora, Performance Analyst, Cody Reneau, Performance Analyst, Controller's Office, presented the report.

PUBLIC COMMENT:

Monica Newcomb stated that it's difficult for people to pay attention to Muni changes while living their daily lives. She suggested that staff create better means of communication besides the internet, and work to connect people to services they are using. Staff needs to think about how to provide information considering sometimes people can't be aware of everything.

William Stuart, Principal Security Manager, Finance and Information Technology division, presented the report.

PUBLIC COMMENT:

Monica Newcomb asked if all of the items were related to Muni and if any addressed public identify theft. She inquired if the public should keep all of their Muni rider tickets.

7. Presentation, discussion and possible action regarding the status of Twin Peaks construction and preparation for the return to full rail service. (Explanatory documents include a slide presentation.)

Siew Chin Young, Director, Capital Planning and Construction, Win Wong, Project Construction Manager, Julie Kirschbaum, Chief Transportation Officer, Transit Operations, Candace Sue, Director Communications and Marketing, and Phillip Pierce, Public Relations Officer, presented the report.

PUBLIC COMMENT:

Michelle Carter stated that the outreach approach is great but it did not include the tenants. Specifically, non-ownership renters were not informed until five days before the project started. It was not made clear that materials and debris would be dumped in front of their units every night at 3:00 a.m. It's not possible to get sleep with the sound of metal on metal screeching. This is a health issue and frustrating for chronic insomniacs. She inquired about the appropriate staff person to discuss these issues with and if a California Environmental Quality Act exemption was obtained. A noise assessment was done but only in the tunnel.

Monica Newcomb stated that there is a dilemma on how to make a big project work and keep negative impacts in control. Construction needs to be respectful of green lives like trees.
