1. Call to Order

5. Report of the Chair (For discussion only)

No public comment.

Chairman Weaver reported that the SFMTA will be setting up a special light rail vehicle (LRV) with alternative seating, so the public can get a feel for the alternative seating options. He also stated that the January 3rd CAC meeting will be canceled.

6. Public Comment:

Johnny Schenone stated that Storer is illegally staging a casino bus in the red zone on Bacon Street between Bayshore and San Bruno. He was told by staff that they have been ticketing them frequently, however, the SFMTA still gave them a commuter shuttle program permit.

Council member Joan Downey arrived at 5:46 p.m.

Edward Mason provided an update on corporate commuter buses in Noe Valley including buses operating without license plates or shuttle program permits and idling during "Spare the Air" days. In the peak hour, there are 40 buses on 24th street. It's a considerable strain on the neighborhood and a safety concern.

Ryan Reeves, Vision Zero Coordinator, gave an update on Vision Zero including the severe injury trends and the action strategy of the program.

Edward Mason inquired if the San Francisco Police Department (SFPD) still does a synopsis of all traffic deaths for the year.

Jadie Wasilco, State and Federal Legislative Analyst, reviewed the state and federal legislative priorities of the SFMTA.

Edward Mason inquired if there is any legislation involving intercounty express buses and if there is any legislation to remove the California Public Utilities Commission (CPUC) oversight of Transportation Network Companies (TNCs). The Transportation Sustainability Fee is a joke.

Timothy Manglicmot, Manager, Capital Financial Planning, presented the item. He provided an update on the CIP policy goals, development process, and project highlights.

Edward Mason inquired where the money will come from if someone files a claim regarding Central Subway. Muni is having staffing problems which causes bunches and 30-minute delays on the J line.
