

Muni Forward As-Needed Construction Project Update – CSO #2



Upcoming Construction Activity: Construction of a Sidewalk Bulb Out, Roadway Regrading and Concrete street repair work at the intersection of Middle Point Road and Innes Avenue will require temporary road closures and traffic detours during different phases of construction activity.

Upcoming Construction: Sidewalk Bulb-Out, Roadway Regrading and Concrete Street Repair

Dear Middle Point Road and Innes Avenue Neighbor,

San Francisco Public Works will soon begin sidewalk bulb-out installation, roadway regrading and concrete street repair activity at the intersection of **Middle Point Road and Innes Avenue** as part of the ongoing **Muni Forward As-Needed Construction Project** (Contract No. 2852J - CSO #2).

Construction activity is anticipated to begin the week of **February 19, 2019** and will continue through early-**April 2019***.

A follow up notice with additional construction information a will be delivered to area residents by the contractor, **A. Ruiz Construction Co.**

During different phases of construction, **Muni** and **traffic detours** may be implemented to navigate around the work area. Please observe and follow traffic detour signage and follow instructions from crewmembers.

Monday - Friday: 7 AM - 7 PM (Please note: Weekend work may be possible, but has not been scheduled at this time.)

We thank you in advance for your patience during construction and as we work to complete these much needed infrastructure improvements to San Francisco.

*Please Note: Construction scheduling and sequencing is subject to change and dates may be accelerated or delayed due to rain or other weather delays, equipment breakdown, and/or unforeseen field conditions. Please see posted "No Parking" barricades for exact restricted parking dates. Restrictions may vary per block.

Impacts and Restrictions

Street parking will be restricted in the immediate work area during general work hours.

"**No Parking/Tow Away**" signs will be posted 72 hours in advance of work starting with dates and hours of restricted parking.**

Vehicles parked in the construction zone during posted work hours will be towed at the vehicle owner's expense.

Access to private or commercial buildings via the public right of way/sidewalks will be maintained at all times. **Vehicle access** to private driveways may be impacted/restricted for short durations during different phases of work.

Due to the nature of concrete street construction, there WILL be some days when vehicle access may be fully restricted. In addition, Muni service will be re-routed. Temporary bus stop information will be posted at the bus stops and will be available at: http://bit.ly/sfmtatsr. Crews will work on one half of the street at a time during demolition, repair and construction of the concrete street. Once concrete is poured, access may be fully restricted for up to 10 days to allow for the concrete to fully cure.

Please observe posted no parking hours and traffic signage and allow extra travel time in case of traffic delays during construction.

**Please see posted "No Parking/ Tow Away" signs for restricted parking hours, which may differ from general work hours.
