## ORDER OF BUSINESS

## 1. Call to Order

3. Announcement of prohibition of sound producing devices during the meeting.

Board Secretary Boomer announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. She advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

Ed Reiskin, Director of Transportation, discussed two recent fatalities, and Muni service changes going into effect on June 15.

Director Eaken requested a presentation on how to make streets safer for pedestrians.

Vice Chair Borden requested a report on the impact of BART's work on Muni service.

Julie Kirschbaum, Director, Transit, presented the update on transit service.

Chair Heinicke requested information about the plan for system-wide communications at the next report and possible solutions for the pocket design flaw at the Embarcadero in a future presentation.

Supervisor Asha Safai stated that his office had been contacted by neighbors on the 54 Fulton (Item 12). The street the bus runs on is a narrow street where two cars can't pass. His office initiated a process to reroute the 54 Felton line and has spent the last six months working on a plan with the community. The proposal is solid and he is in support, as it will improve service.

#### PUBLIC COMMENT:

Herbert Weiner expressed appreciation for the report. He wondered what the net addition of vehicles to the fleet were. People have to walk longer distances. The Board needs to increase the density of buses that are available. There are the same amount of vehicles but people have to walk longer distances. The SFMTA has to add more buses to the lines commensurate with the increased population.

Evie Passimentere expressed appreciation to the SFMTA for the work that's being done. People are seeing issues at the very start of the purchase of the new light rail vehicles. She wondered whether there was a warranty on the entire purchase. The SFMTA was sold a bill of goods. She discussed the light rail vehicle doors and disabled seats. The vehicles need to be in compliance with the Americans with Disabilities Act.

#### 9. Public Comment

Helena Sears expressed appreciation for the letter addressing issues that she had raised previously. There hasn't been a concrete solution. She asked for clear language before the next bike share permits are issued.

Rob Schwartz stated that bike rentals are part of the solution to the bike share program. They serve a large segment of bike riders who want to ride to Sausalito. There's a complimentary aspect between bike rentals and bike share. Mr. Reiskin wants to reinforce the distinction between bike share and bike rentals. He requested bike share companies prioritize short term rentals.

Herbert Weiner commended the Chair's efforts to improve the SFMTA but at the last meeting, he was conversing with another member of the board while he was speaking. This was disrespectful. He requested the Board's undivided attention.

Sean Sears asked the SFMTA to include critical language in upcoming bike share permit program.

- A. ESTABLISH STOP SIGN Lyon Street, northbound, at Turk Boulevard.
- B. ESTABLISH NO PARKING, 6 AM TO 8 AM, MONDAYS Minnesota Street, west side, from 440 feet to 449 feet north of 22nd Street.
- C. ESTABLISH STOP SIGNS Cabrillo Street, eastbound and westbound, at 20th Avenue.
- D. ESTABLISH RED ZONES Judson Avenue, south side, from Foerster Street to 53 feet easterly; Judson Avenue, south side, from Foerster Street to 20 feet westerly; Judson Avenue, south side, from west Gennessee Street curb line to 29 feet easterly; and Judson Avenue, south side, from Gennessee Street to 20 feet westerly.
- E. ESTABLISH TOW AWAY, NO PARKING ANYTIME California Street, south side, from 16th Avenue to 40 feet easterly. (Explanatory documents include a staff report and resolution. For every parking and traffic modification that received a categorical exemption, the proposed action is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code.)

- E. RESCIND MUNI FLAG STOP Portola Drive, south side, at Claremont Boulevard (relocated east); Vicente Street, south side, east of West Portal Avenue
- F. ESTABLISH MUNI FLAG STOP Portola Drive, south side, east of Claremont Boulevard
- G. ESTABLISH PASSENGER LOADING ZONE, 7 AM TO 6 PM, MONDAY THROUGH FRIDAY Ulloa Street, south side, from 20 feet to feet 70 feet west of West Portal Avenue
- H. ESTABLISH NO LEFT TURN, 6 AM TO 10 AM, MONDAY THROUGH FRIDAY, EXCEPT MUNI –Lenox Way, southbound, at Ulloa Street
- I. ESTABLISH NO U-TURN AT ALL TIMES West Portal Avenue, Northbound at Ulloa Avenue. (Explanatory documents include a staff report, amendment and resolution. Erica Maybaum, aide to Supervisor Yee discussed various concerns with the pilot project including community outreach, and the location of the 48 Quintara line. The supervisor supports certain aspects of the plan but urged that the pilot be delayed for 90 days. The area was impacted by the closure of the tunnel and merchants are still experiencing reduced revenues. She requested performance metrics and a cost-benefit analysis for each aspect of the pilot.

Chair Heinicke stated that the Board expects ongoing dialogue with the community throughout the pilot.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
