## ORDER OF BUSINESS

## 1. Call to Order

Vice Chair Borden called the meeting to order at 1:02 p.m.

## 2. Roll Call

- Present: Gwyneth Borden Cheryl Brinkman Amanda Eaken Malcolm Heinicke – absent at Roll Call Steve Heminger Cristina Rubke Art Torres
- 3. Announcement of prohibition of sound producing devices during the meeting.

Board Secretary Boomer announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. She advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

No public comment.

On motion to approve the minutes of the November 5, 2019 Regular Meeting: unanimously approved (Heinicke-absent).

5. Communications

6. Introduction of New or Unfinished Business by Board Members

Director Brinkman requested an update on the Embarcadero quick build project.

Director Rubke asked that the "Getting to the Curb" booklet be provided board members.

7. Director's Report (For discussion only)

-Update on Vision Zero -Update on transit service -Ongoing Activities

Tom Maguire, interim Director of Transportation discussed two recent fatalities, election results, Federal Transit Administration Triennial Review, Safe Driver Awards event, ConnectSF, and Winter Walk.

The update on transit service was postponed to later in the meeting.

Vice Chair Borden requested discussion about slowing down speed limits.

Director Eaken requested discussion about how to change driver behaviors.

## **PUBLIC COMMENT:**

Robin Krop discussed safety on the streets. There are two angles: drivers and pedestrians. Drivers speed through red lights all the time. That's a set up to hit someone. There needs to be a public campaign to not run a red light. She suggested something about "you can wait" in an education campaign. Pedestrians are crossing the street while looking at their cell phone. Pedestrians must see where the cars are. There needs to be a campaign for pedestrians as well.

Elizabeth Kurhan stated that she was blown away that cyclists don't know the rules. The Department of Motor Vehicles doesn't cover pedestrian nor cyclist safety.

#### 8. Citizens' Advisory Council Report

Neil Ballard, Chair, Finance and Administration Committee, Citizens' Advisory Council, presented a recommendation regarding bunching and gapping of transit vehicles.

#### 9. Public Comment

Ruth Badetsky discussed how she walks, bikes, drives, and takes Muni every day. She recounted a story where she got a ticket from a camera onboard a bus when they were briefly stopped in a red lane. The ticket was justified. She expressed appreciation for the enforcement and suggested the same for enforcing people who stop in protected bike lanes.

Mark Gruberg discussed his lack of faith in the SFMTA and a study that Mr. Tumlin participated in a few years ago.

Herbert Weiner discussed project planning. People who are going to be affected aren't involved in the early stages of planning but are presented with a fait accompli. This results in unrealistic plans. Buses running at the same speed with the same lousy service but with no improvements. People must be involved in the initial stages of planning.

Matthew Ajiake expressed interest in diversity, equity, and inclusion both in contracting and in employment.

## CONSENT CALENDAR

- A. ESTABLISH RESIDENTIAL PERMIT PARKING AREA X 1601-1695 18th Street.
- B. ESTABLISH TOW-AWAY, NO STOPPING ANYTIME Masonic Avenue, west side, from Geary Boulevard to 155 feet northerly.
- C. ESTABLISH TOW-AWAY, NO STOPPING EXCEPT PERMITTED CAR SHARE VEHICLES – Golden Gate Ave, north side, from 40 to 80 feet west of Polk Street; Brighton Avenue, west side, from 20 feet to 40 feet south of Ocean Avenue.
- D. ESTABLISH TOW-AWAY, NO STOPPING ANYTIME ESTABLISH SIDEWALK EXTENSION; Tennessee Street, east side, from 19th Street to 128 feet northerly.
- E. ESTABLISH PASSENGER LOADING ZONE, AT ALL TIMES Tennessee Street, east side, from 128 to 150 feet north of 19th Street.
- F. ESTABLISH RED ZONE ESTABLISH SIDEWALK EXTENSION (6 FEET); 19th Street, north side, from Tennessee Street to 23 feet easterly.
- G. ESTABLISH SPEED TABLES 17th Street, between Market Street and Diamond Street.
- H. ESTABLISH CROSSWALK 17th Street, midblock between Diamond Street and Castro Street.
- ESTABLISH CLASS IV BIKEWAY 17th Street, westbound, from Castro Street to 200 feet westerly; and making environmental review findings. (Explanatory documents include a staff report and resolution. For every parking and traffic modification that received a categorical exemption, the proposed action is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code.)

- A. ESTABLISH TOW-AWAY, NO STOPPING ANYTIME EXCEPT VEHICLES DISPLAYING A PERMIT ISSUED BY THE SFMTA, 6 AM TO 6 PM, MONDAY THROUGH SATURDAY — Turk Street, north side, from 411 feet to 211 feet west of Gough Street and Turk Street, south side, from 369 feet to 169 feet west of Gough Street.
- B. ESTABLISH TOW-AWAY, NO STOPPING ANYTIME EXCEPT VEHICLES DISPLAYING A PERMIT ISSUED BY THE SFMTA, AT ALL TIMES, - Turk Street, north and south side, from Laguna Street to 435 feet east. - J. ESTABLISH TOW-AWAY, NO STOPPING, MONDAY TO FRIDAY, 7 AM 10 AM AND 3 PM 6 PM Haight Street, south side, from 154 feet west of Buchanan Street to Webster Street

Director Brinkman asked staff to consider extending parking meters to later in the evening on Haight Street.

The Board asked staff to report back in four months, including potential changes to Haight Street and education to the public and to limit the project to 12 months.

**PUBLIC COMMENT:** 

Herbert Weiner asked if the report was going to be reviewed by the Muni Task Force. Buses are behind schedule and service is very uneven. He would also like to see the workplace bullying within the SFMTA addressed as it impacts service. The command, communication, and control structure need to be reviewed.

Edward Mason questioned hiring of new employees. Both the Valley Transportation Agency (VTA) and Santa Cruz Transit sends out daily notices about the lack of service due to employee shortages. VTA has hired retirees to provide service. With hiring problems in the South Bay, Mr. Mason questioned how the SFMTA would increase their employment opportunities.

12. Authorizing the Director to execute Contract Modification No. 6 to Contract No. 2013-19: Procurement of New Light Rail Vehicles, with Siemens Mobility, Inc., to enhance the vehicle design with passenger comforts, updated operator cab features, and engineering refinements that improve fleet performance; and to advance Phase 2 long-lead activities to accelerate fleet replacement, for an amount not to exceed \$9,799,688, with no increase in the total Contract price, and no increase in the term. <u>California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption

determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
