# ORDER OF BUSINESS

Edward Mason recommended that the platform on the north side of Market Street at Church be restored and a wheelchair ramp added on the J Church line. The temporary platform has broken parts and the road closed sign seems to only be a recommendation to drivers.

David Pilpel stated that he hopes the J Church remains in the subway. The temporary stops south of Market should be removed. There needs to be wide enough islands and ramps in both directions.

Edward Mason asked how the SFMTA is addressing the difference in meantime between failure of Breda versus Siemens cars. He wondered if there is a maintainability analysis based on the failure of equipment to determine the time for replacement between component parts. He considered the SFMTA plan for the state of good repair as the bottom of the iceberg.

David Pilpel stated that he supports the information presented by staff and the efforts of the agency.

Frank Zepeda asked which Bredas and motorcoaches are up to date with midlife overhaul.

Stephen Cornell asked how rail-slapping is being addressed at 24<sup>th</sup> and Church.

Edward Mason stated that Siemens car 2014 has the new seats installed. Its operating on the J Church line. He requested that the SFMTA consider the Siemens fleet defects and transit priority signaling system and the implementation of it. He also discussed rail-slapping.
