

PUBLIC HEARING RESULTS

Pursuant to SFMTA Order No. 6594, the San Francisco Municipal Transportation Agency held an online public hearing on Friday, November 18, 2022 regarding the following proposed changes. ESTABLISH – WHITE ZONE, PASSENGER LOADING, 7AM TO 10PM, DAILY

27 Dashiell Hammett Street, west side, from 117 feet to 139 feet north of Bush Street (22-foot zone) - No opposition received; approved by the City Traffic Engineer and forwarded for implementation by Directive 6595.

ESTABLISH – WHITE ZONE, PASSENGER LOADING, 7:30AM TO 9:30AM AND 3:30PM TO 5:30PM, MONDAY THROUGH FRIDAY

"65" Flora Street, east side, from 138 feet to 204 feet north of Thornton Avenue (66-foot zone) - No opposition received; approved by the City Traffic Engineer and forwarded for implementation by Directive 6595.
