6. Introduction of New or Unfinished Business by Board Members

Chair Eaken acknowledged and thanked former Director Gwyneth Borden for her service.

Director Cajina joined the meeting.



Director Yekutiel thanked Director Borden for her service and acknowledged the Potrero Yard team, N Judah train maintenance team, and reflected about bus shelters and service in the city.

Director Cajina echoed sentiments about Director Borden. She also shared about presenting at the Human Rights Commission and the agency's equity goals related to safety and access.

Director Heminger thanked Director Borden and looked forward to seeing her soon in a capacity that would produce more results and good policy for the city.

Director Hinze thanked Director Borden for being a mentor and sharing her knowledge, acknowledging that she did a great job centering equity, riders, and staff.

PUBLIC COMMENT:

Barry Taranto thanked Director Borden for her service to the agency and commented about an upcoming paratransit meeting.

Tom Maguire, Director of Streets, presented the report. He shared about the Slow Streets Evaluation Report, Twin Peaks Tunnel inspection, Sunday Streets, Sideshow deterrence techniques, Capp Street update, Rail Roadeo, the new sculpture at the Yerba Buena Station, Bike and Roll to School Week, the Active Communities Plan, and upcoming service for the NBA playoffs.

#### PUBLIC COMMENT:

Roz Arbel expressed concern about Slow Streets and called for better infrastructure and education.

Ruth Malone expressed concern about the Slow Streets Evaluation Report and urged the SFMTA to add diverters to eliminate through traffic.

Joseph Tartacovsky expressed concern for Slow Streets data collection, sharing that it should be revised to and measure segments of the street, not the entirety of the street.



Jaime Viloria asked the SFMTA to improve wayfinding at the Union Square Station.

JP Lavallde expressed concern about safety on Slow Streets, sharing that on Lake Street drivers go too fast.

Trish Gump expressed support for slow streets and urged the SFMTA to add all the original streets back into the program.

Naomi Lochner expressed opposition to adding Chenery Street as a Slow Street, sharing that neighbors do not want it as a slow street.

Jana Paradiso expressed concern about Chenery Slow Street.

Charlie Toohey expressed opposition on Chenery Slow Street.

John Biasatti shared that there was no official support for Chenery Slow Street and that most of the community is against the slow street.

Katherine Murphy expressed opposition to Chenery Slow Street.

Kathleen Tracey expressed opposition to Chenery Slow Street, surrounding single lane streets, and nearby schools.

Laura Yakovenko supported a Slow Streets Network and expressed concern about speeding, cut through drivers, the need for hard diverters on Lake Street.

Catherine expressed concern about the Slow Streets Evaluation Report, sharing that the data should be more tailored to a location.

Speaker expressed concern about the Slow Street evaluation and data accuracy.

Aleta Dupree looked forward to Sunday Streets and appreciated the new art at Yerba Buena Station.

Michael Adley thanked staff for preparing the Slow Streets Evaluation Report and asked for better traffic diverters.

Luke Bornheimer expressed concern about ineffective infrastructure on Slow Streets, also sharing that the agency needs to address cut through traffic.



Barry Taranto expressed concern about Transportation Network Companies occupying the taxi staging areas at the Chase Center.

Brian commented on the Slow Streets evaluation report and requested that the SFMTA use traffic diverters on all Slow Streets.

Lian Chang expressed concern about the Slow Streets Evaluation Report.

Aleta Dupree shared about using Muni and inclusiveness on transit.

Speaker commented about climate change and impacts to erosion on Ocean Beach.

Paula Katz submitted the following public comment summary per Administrative Code Section 67.16:

Many of us are looking forward to seeing the revised minutes of the February 7, 2023, special meeting with the panelist of community and business leaders who presented input, ideas, and insights on building trust. We are glad that the public will be able to read a summary of the suggestions and ideas that the panel presented to you.

Barry Taranto expressed concern for taxi medallion holders and taxi enforcement, urging the Board to build trust with the taxi industry.

Mason Church was opposed to the 10-minute time limit for remote public comment and urged the SFMTA to do a better job to get people to participate.

Luke Bornheimer expressed concern about bike infrastructure, urged the Board to install protected bike lanes on Arguello Boulevard, and to identify and convert other streets.

Jonathan Rewers, Chief Strategy Officer, John Canapary, Executive Vice President, Corey, Canapary & Galanis, Lucia De Puppo, Senior Vice President, FM3, and Beth Resta, Partnerships at Transit App presented the item.



PUBLIC COMMENT:

Aleta Dupree commented that there are some communities not being heard in the surveys and asked about how Muni can be approachable.

Paula Katz submitted the following public comment summary per Administrative Code Section 67.16:

Slides 49 & 51 show the same percentages of survey takers want both frequent, reliable buses even if stops are more than 2 or 3 blocks from where they live, and also service that is accessible to all, with improved access for the disabled. These goals are inconsistent because removing bus stops to get faster service can cause difficulties for many vulnerable seniors, the disabled, and others who have to walk farther to catch MUNI, but SFMTA surveys don't tell riders this. Many riders want it easier, not harder, for their elderly parents, relatives, neighbors to catch Muni. Surveys should specifically ask if it's ok to remove bus stops to create more frequent, reliable service if it means that seniors, the disabled, and others might have difficulty walking extra blocks to catch their bus. Then let riders pick between faster service versus easier access for the elderly and disabled.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
