The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, September 13, 2013, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:
