5. Report of the Chair (For discussion only)

Chair Leifer welcomed Julie Kirschbaum, Director of Transportation and Brent Jones, Acting Director of Transit. Director Kirschbaum gave a brief history of her time at the agency. She discussed her focus and plans as the new Director of Transportation.

Director Jones talked about efficiency, accountability, and development. He discussed his work to improve the training process, soft skills, and employee development. Director Jones said he has an innovative, futuristic vision for Muni service and that he is ready for the challenge.

PUBLIC COMMENT:

Edward Mason discussed Transit Operator Appreciation Day. He stated that the birthrate is not sustaining the population and encouraged Muni to create a training program



6. Public Comment

Edward Mason said that 24th street is experiencing sewer replacement and repair which has affected parking lanes by converting them into temporary traffic lanes. Commuter shuttle buses are taking up the white zones which are now traffic lanes lanes and Muni buses are being impacted. He said the 48 lines have been bunching due to the delays caused by construction and the inconsistency of the reroute amongst the Operators.

CAC MOTION 250306.01

The SFMTA CAC urges the SFMTA Board of Directors to continue to require that upfront fares be within 10 percent or less of taximeter fares. The current regulated system has been in place for decades to provide reasonable charges to customers and fair rates of return for taxi drivers. It now creates a buffer against the unregulated and potentially exploitative system employed by the TNC industry.

Furthermore, the SFMTA CAC urges the SFMTA Board of Directors to delay action on adopting a permanent program for Third Party Dispatch until accurate data from the latest quarters is available. If and when the Board of Directors does take action on Third Party Dispatch, the SFMTA CAC urges the Board of Directors to set meter rates for taxis dispatched by third parties and to demand greater data sharing by Third Party Dispatch companies. The SFMTA CAC notes that according to Sec. 8A.101 of the city charter, the SFMTA has "exclusive authority over ... taxi-related fares, fees, charges, budgets and personnel".

Chair Leifer moved to strike the second paragraph of the motion.
