#### CARB amendment proposals

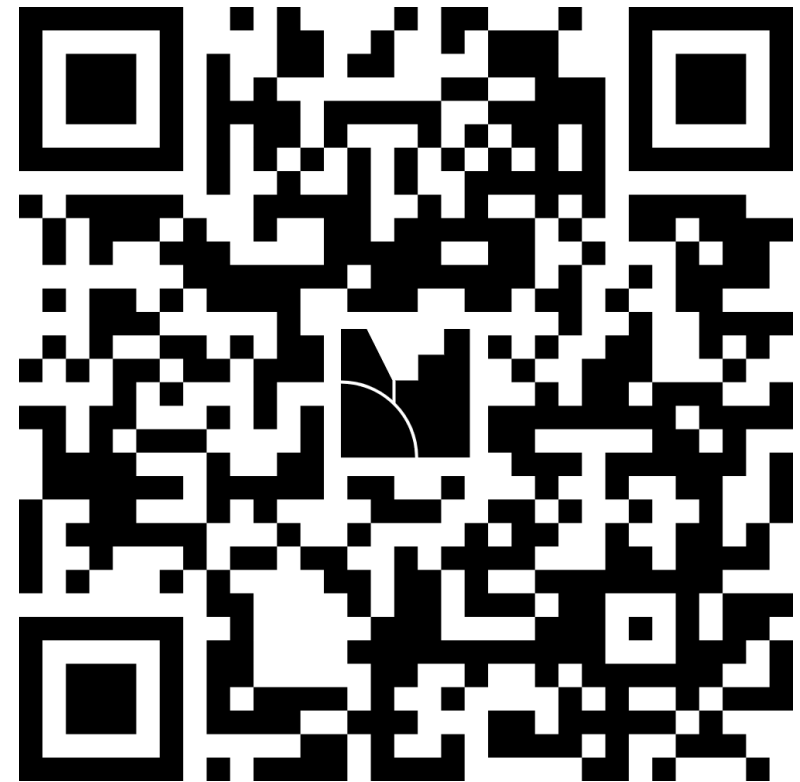
- Proposed amendment would extend shuttle operations until November 2027

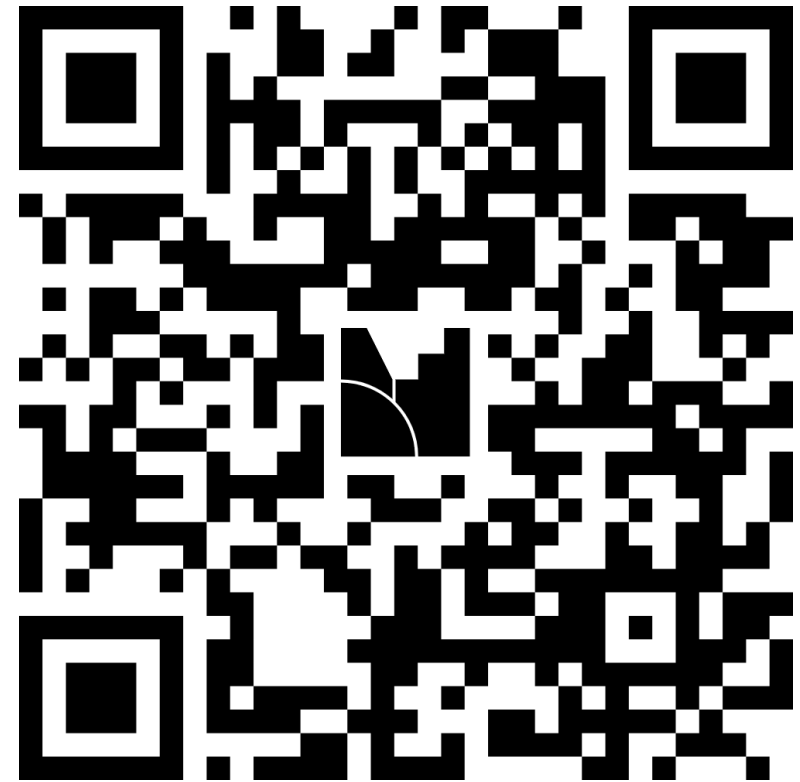

# Community Congress Bylaws

## Article I. and II. Purpose and Membership

### Article I. Purpose

1. Put D10 residents needs and interests first
2. Decision making body for STEP

### Article II. Membership

- Live, work, worship in D10 or have historical ties to the area
- Attend meetings
- 3 unexcused absences
- Ability to resign

# Community Congress Bylaws

## Article III. IV. and VI.

### Article III. Meetings

- Meetings occur once a quarter
- Majority of members (8) are required for quorum and a vote

### Article IV. Officers

- Officers manage the meeting and agenda and can be removed by vote

### Article IV. Conflicts of Interest

- Ensure decisions or Congress names don't benefit the private interest of a Congress member
- Delegates can't accept favors or payments from contractors/vendors
- Must disclose conflicts of interests and not vote on those matters

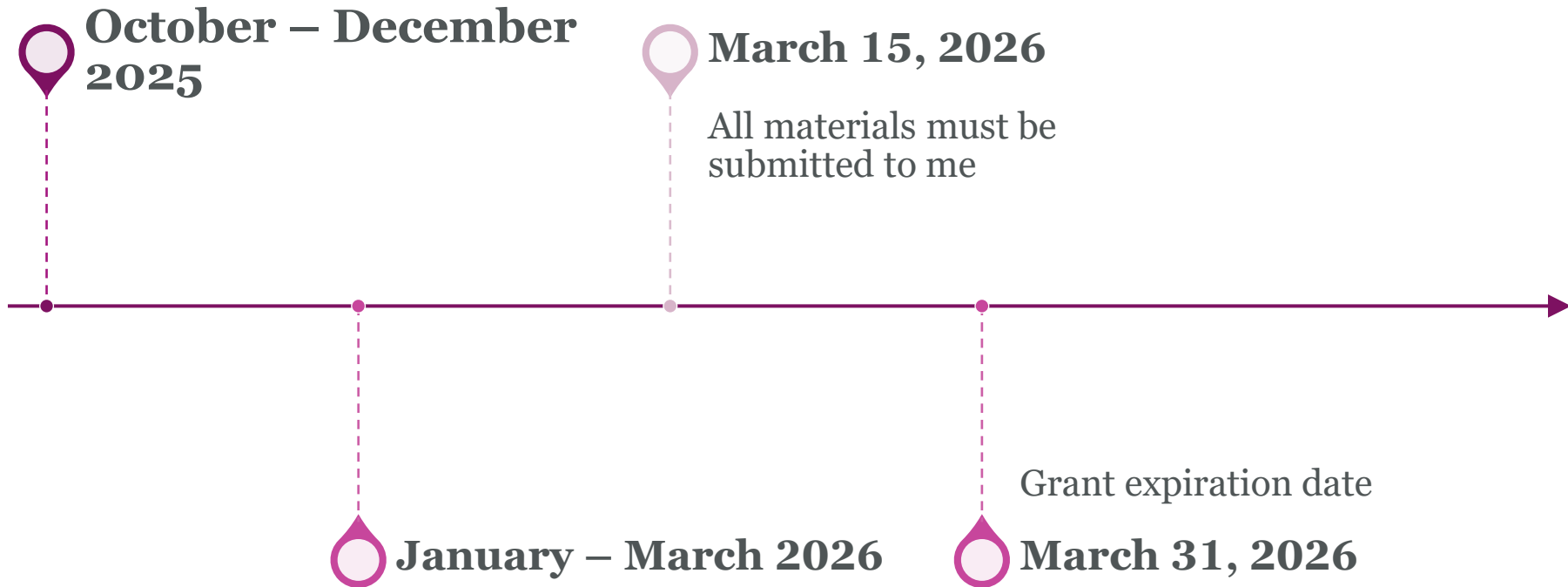
