ORDER OF BUSINESS

1. Call to Order

Chairman Nolan called the meeting to order at 1:00 p.m.

2. Roll Call

- Present: Cheryl Brinkman Gwyneth Borden Malcolm Heinicke – absent at Roll Call Tom Nolan Joél Ramos Cristina Rubke
- 3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

On motion to approve the minutes of the April 21, 2015 Regular Meeting: unanimously approved (Heinicke-absent).

5. Communications

Chairman Nolan stated that he would ask the Board Secretary to call Items 11 and 12 together following the CAC report.

Board Secretary Boomer stated that there would be no closed session.

6. Introduction of New or Unfinished Business by Board Members

Noting the recent unreliability of station elevators, Director Rubke requested a report on the reliability and condition of the elevators as well as the SFMTA's ability to communicate these issues to riders.

7. Director's Report (For discussion only)

-Special Recognition Award -Ongoing Activities Director Heinicke arrived.

Tom Maguire, Director, Sustainable Streets recognized Mari Hunter, Senior Planner, Strategic Planning & Policy Division, Sustainable Streets. Gerald Williams, Safety Officer, presented the Quarterly Safety Award to the Potrero Bus Maintenance Division.

No public comment.

8. Citizens' Advisory Council Report

Daniel Weaver, Chairman, Citizen's Advisory Council, presented the report.

9. Public Comment

Richard Hybels discussed color scheme renewal fees. Last year, the fee was waived. This year the fee is back and unchanged. There is a disparity in the fees between the larger and smaller color schemes. There is also an appearance of impropriety at the deference shown to large color schemes. His company is closing their doors at the end of the month.

Jim Templeton stated that the taxi matters on the agenda are window dressing. Cab drivers would gladly pay the fees if the SFMTA did its' job. The only way this can happen is because of political corruption. Mr. Templeton wondered how the Mayor can allow Uber and Lyft to work at the airport when those cars should be towed because they're committing insurance fraud. Taxis can't compete with TNC's.

Herbert Weiner stated that on May 14, Bike to Work Day, he expects cyclists to obey traffic signals. He also expects the SF Bike Coalition and anyone who rides a bicycle from the SFMTA Board or in government to obey the traffic signals. This should be a day of model behavior.

Tone Lee discussed the construction for the Central Subway Project. A lot of drunk drivers at night can get hit because of this construction Pre-K owners own big apartment properties. Cab drivers want to see their own color scheme. There are too many color schemes and everyone is making money off of cab drivers.

Barry Taranto stated that everyone is thinking about what Mr. Templeton said. Part of the violence is between TNC and cab drivers. The SFMTA doesn't help taxi drivers out. Full service companies have dispatch services but it's hard to get them on the phone during off hours. There is turmoil in the industry and companies are closing or hurting financially. The industry deserves to get information on a regular basis.

Carl Macmurdo stated that cab drivers receive a business registration renewal form from the Controller which is very confusing to recent immigrants who don't speak English well or don't own or use a computer. The fee is \$91 for all drivers. The entire exercise of dragging all drivers through a process for \$91 is a waste of time. The Controller should allow cab drivers to pay by check or in person.

Dave Schneider addressed the issue of the panic button. San Francisco can set the standard. The problem with the old panic buttons is that they could be inadvertently triggered. There are other places to locate a panic button that can be connected directly to the police rather than to a dispatcher who may not pick up a phone. San Francisco should have the highest degree of care.

S. Seligson stated that taxicabs are losing a lot of airport business to the "black cars" that are sitting in white zones. Cars in a white zone must be actively loading or unloading or going to the post office. This should be enforced. He also suggested a sign at hotels that list the taxi fares and the cost to go to the airport.

Kenji Koblenzer stated that Mr. Reiskin was asked why on-time performance was below its' goals. Mr. Reiskin didn't include the traffic gridlock caused by thousands of TNC's. These cars line up and double-park in bus zones. There is an epidemic of U-turns, and stopping in bike lanes. While the TNC's may not be within the SFMTA's jurisdiction, controlling the streets is.

Tariq Mehmood stated that SFMTA created a taxi advisory task force but there are two medallion holders on it. He requested that the composition be changed because there should be taxi drivers in those seats. Taxi drivers are treated miserably. They need to serve the public but it should be a fair competition between taxis and TNC's. The SFMTA should set up a task force to study how to be fair. Cab drivers want a free and independent color scheme.

David Smith stated that the TNC's are aggressive and nasty at after-hours or late night spots. Traffic is terrible and has never been as bad as it is today. The problem is bigger than what SFMTA staff can handle. Parking Control Officers should get TNC's out of hotel zones and everywhere else. Independent color schemes aren't a bad thing but there needs to be rules.

Mikhail Chernobilsky stated that if the SFMTA can't waive something for everybody, they should do it for drivers who bought medallions.

<u>California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
