7. Presentation, discussion and possible action regarding kids on buses after school. (Sulu Palega, Muni Transit Assistant Program Manager of Security and Enforcement, Security, Investigations & Enforcement, Sustainable Streets)

Sulu Palega discussed the Muni Transit Assistant Program (MTAP) staff procedures. The MTAP staff works closely with police and they ride various Muni vehicles near troublesome schools to prevent student behavior disruption on buses.

# Motion 130312.01

The SFMTA CAC recommends that new operator training include MTAP training.

# Motion 130312.02

The SFMTA CAC recommends that the staff be increased for the MTAP so they can cover more lines and education in the schools.

# Motion 130312.03

The SFMTA CAC recommends that the CAC write a letter to the superintendent of schools suggesting that there should be more staggered times for the opening/closing of schools, to alleviate congestion on the buses.

Edward Mason commented on the bus education for students, bicyclists, cab drivers; staggering school hours; and traffic congestion around schools.

8. Presentation, discussion and possible action regarding cable car operations. (David Banbury, Superintendent, Cable Car Division, Transit Services)

John Haley, Director, Transit Services discussed the schedule and supervision of cable car operations. Mr. Haley stated that the cable car is heaviest used on Saturdays and Sundays. Mr. Haley also discussed the disruption to the cable car system when the cables were spliced in November and maintenance procedures for cable cars.
