California Street Safety Project



The SFMTA proposes to reconfigure California Street from four lanes to three from Park Presidio to Arguello boulevards. Instead of two lanes in each direction, there would be one lane in each direction with a center turn lane. In addition to these changes, daylighting of intersections, high-visibility crosswalks, and additional safety improvements will be made to the street from 18th Avenue to Arguello Boulevard.

This project is part of the California Street Safety Project that aims to improve pedestrian and transit safety, increase transit reliability, and decrease traffic collisions. California Street is part of the City's Vision Zero High-Injury Network. The High Injury Network consists of the 13 percent of all San Francisco streets that account for 75 percent of severe and fatal collision.

- California Street from Park Presidio to Arguello boulevards: Proposed reconfiguration of California Street from four lanes to three. Instead of two lanes in each direction, there would be one lane in each direction, with a center turn lane. This design, (1) allows for future pedestrian safety islands, (2) is safer for pedestrians to cross than a "2 and 1" lane configuration, and (3) allows Muni and cars to pass stopped vehicles.
- California Street at Arguello Boulevard: Proposed conversion of a westbound curbside through traffic lane into a RIGHT LANE MUST TURN RIGHT.
- California Street from 18th Avenue to Arguello Boulevard: Proposed quick-build pedestrian and transit safety elements such as daylighting, high-visibility crosswalks, and other improvements to street to improve safety and decrease collisions.
