ORDER OF BUSINESS

1. Call to Order

Chair Borden called the meeting to order at 1:00 p.m.

2. Roll Call

4. Approval of Minutes

PUBLIC COMMENT:

David Pilpel stated that a member of the public's name was spelled incorrectly. Jerry Russ should be Gary Russ.

On motion to approve the minutes of the December 15, 2020 Regular Meeting: unanimously approved.

5. Communications

Chair Borden discussed the virtual meeting and expressed appreciation to staff for their work to enable the meeting to be held via teleconference. Board Secretary Celaya reviewed how members of the public could watch the meeting and address the Board.

7. Director's Report (For discussion only)

-Update on Vision Zero -Ongoing Activities

PUBLIC COMMENT:

Aleta Dupree discussed autonomous vehicles and is looking forward to using them. Autonomous vehicles can be helpful to people with disabilities and they also help the environment. These vehicles

handle more rides and help with Vision Zero goals. She supports state level oversight so the vehicles can be used regionally. She urged the agency to get repairs done and open the subway.

Jody Mederios stated that the threat of traffic violence is rising and so are deadly speeds. In 2020, there were 29 traffic deaths which is the same as in 2019. Traffic safety is a challenge with solutions that save lives. The city has fiscal challenges, but the cost of inaction is greater. He urged the SFMTA renew its' focus on traffic safety. Walk SF is here to support the agency.

David Pilpel asked that when the Metropolitan Transportation Commission's allocation of federal bailout money for the region becomes available, to make that information public. There is a possible allocation to the SFMTA. The Agency's use of the California Environmental Quality Act Environmental Impact Report for autonomous vehicles is okay for the SFMTA but it wasn't when he complained. The Youth Commission should have jurisdiction on transit so there shouldn't be a need for an SFMTA Youth Board.

Herbert Weiner stated that since there will now be a Youth Advisory Board there should also be a senior and disabled advisory board. They are second place but they also need a voice since they are 20% of the city's population. He urged the Board to set up a senior and disabled advisory board. Regarding Vision Zero, the safety of pedestrians on the sidewalks should be considered.

Hayden Miller spoke about Vision Zero and is happy that many projects will be implemented. He urged the agency to move away from installing bike posts that are getting destroyed and install concrete instead. When approving Better Market Street, don't implement a watered-down version. He is excited for the January 23 signup and service changes but was disappointed that the SFMTA blog post noted that the N bus was getting the longer 60-foot buses on the weekends but then that was removed. He is concerned that after these changes are made, there still isn't service for the entire city. Bus capacity is a big issue. He urged the agency to create more Slow Streets because everyone should have a right to feel safe. He is excited to possibly serve on the Youth Board.

Alexander thanked the SFMTA for working with the youth commission to create the Youth Board. As a former youth commissioner, he has seen that transit is a huge issue for youth. There needs to be more social media directed towards youth. Ambassadors need to work for everybody, and the Youth Board can bring more attention to their issues

Barry Taranto stated that autonomous vehicles are going to be a problem. There are a lot of questions that need to be address. He expressed appreciation to the SFMTA for asking for a hearing on the California Public Utilities Commission decision. There are too many micro mobility users on the road that don't pay attention to traffic rules. Regarding Vision Zero, the Agency needs to work with the police department on corridors where speed is a problem.

9. Public Comment

Hayden Miller discussed security issues in SFMTA tunnels. He has seen photos of people trespassing in the Sunset tunnel. More security is needed in the yards and in right of way areas such as Dolores Park where there are a lot of trespassers. He suggested fare enforcement staff remind people to pay their fare. Operators are getting in disputes with passengers but that should be done by proof of payment staff and not operators. The bus shelters and stations are dirty. Maintenance isn't being done according to the contract and it's a disgrace to the city.

Richard Rothman stated that speeding drivers kill people. He has been tracking injuries where pedestrians are getting hit in the Outer Richmond. All of these incidents involved senior citizens in crosswalks on streets with a 30mph speed limit. He urged the Board to slow the speed limits down and reengineer the streets. The intersections on Fulton Street where there are plans for daylighting isn't where the incidents are happening. The Director's report should include how may people were hit by cars. When considering closing JFK Blvd., he hopes the SFMTA works with Supervisor Fewer on a solution.

Anonymous discussed the maintenance of rail vehicles, specifically the Breda cars which break down and costs the Agency millions to rehabilitate. The SFMTA leaves cars in the Daly City yard which is open to theft. He urged the Board and the agency to move out of the Daly City yard.

Tyler discussed doing bike orders on Door Dash on Page Street. There are miles of Slow Streets in other parts of the city but in the Tenderloin, residents have gotten almost nothing. He liked that Larkin Street was closed on weekends for outdoor dining. He urged the Board to revisit closing Larkin Street again and creating Slow Streets in the Tenderloin.

Aleta Dupree discussed micro mobility and urged the Board to continue to be positive advocates for all shared mobility options. She would like to see the Agency be more tech forward and urged the Board to continue working with Clipper on all modes.

David Pilpel stated that the new Youth Board will likely be a passive meeting body so there could be some staffing and compliance issues. He hopes the budget materials for the workshop will be available to the public more than three or four days ahead of the meeting. He also hopes staff includes the Citizens' Advisory Council's input.

Barry Taranto stated that he thinks the Youth Advisory Board will make reports to the Board and he believes that the Paratransit Coordinating Council should be given the same opportunity. He urged the SFMTA to push for a centralized dispatch for ramp drivers and to ensure they are at the front of the line for the COVID vaccine. Cab drivers should be considered the same as transit workers in terms of the level of priority for the vaccine. Cab drivers need more personal protection equipment. He asked the agency to increase the 10% tip on paratransit rides given the risk involved and to keep equipment sanitized.

Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
