A) Member Discussion on Vision Zero Strategy Questions from Last Meeting

Ms. Seretan led a discussion with the membership on the Vision Zero Strategy Questions from the February meeting. See "Vision Zero Strategy Discussion".

B) Autonomous Vehicles

Ms. McAulif and Ms. Angotti provided the committee with an update on SFMTA's Autonomous Vehicle policy efforts.

Ms. Seretan stated that it would be very good if designers could make it so that wheelchair users could board the vehicle and be in the front of the car, instead of the back.

Mr. Morgan stated that it is important to think of passengers who may need assistance in getting into and out of the vehicles; there should still be a person in the car to provide passenger assistance, if needed.

Mr. Morgan went on to say that it is likely you will need a person behind the wheel until all the issue with autonomous vehicles can be worked out.



Mr. Yan asked if autonomous vehicles were safe.

Mr. Morgan asked if one could specify a specific vehicle, or if the system would know to specify a specific vehicle based on one's preferences, or disabilities. Example would be to have a ramped van dispatched if one needed it to be able to ride, or a sport utility vehicle dispatched for people who have trouble getting sedans.
