PUBLIC COMMENT:

David Pilpel proposed a correction to the June 15, 2021 meeting minutes to correctly identify that Vice Chair Eaken called the closed session to order.

5. Communications

Chair Borden discussed the virtual meeting and expressed appreciation to staff for their work to enable the meeting to be held via teleconference. Board Secretary Silva reviewed how members of the public could watch the meeting and address the Board.

6. Introduction of New or Unfinished Business by Board Members

Director Hinze requested an update on the Better Market Street Project and an update on school reopening.

No public comment.

Director Tumlin shared updates on Vision Zero, COVID vaccinations and cases, the Central Subway Project, and information about the August 4-9 street closure at South Van Ness Avenue and Mission Street as part of the Van Ness Improvement Project.

PUBLIC COMMENT:

Aleta Dupree encouraged mask use on transit and looked forward to the opening of the Central Subway.

David Pilpel suggested that staff share a report of SFMTA employees that retired since the end of the fiscal year, including the number of individuals and total number of years of service.

8. Citizens' Advisory Council Report

Michael Chen, Chair, Citizen's Advisory Council (CAC), presented the report.

PUBLIC COMMENT:

David Pilpel recognized Daniel Murphy who recently left the CAC after serving for 20 years and suggested that the Board also recognize Mr. Murphy for his significant contributions to the agency.

9. Public Comment

Hammy urged the SFMTA to restore the 52 Excelsior and 43 Masonic lines so he could get to the Disney Museum.

Aleta Dupree shared that she recently rode Muni and expressed concern about fares, urging the SFMTA to help get riders on Clipper START.

Joshua Ochoa thanked the agency for restoring the M Ocean View and 31 Balboa lines and shared that restoration of the 57 Parkmerced and 29R Sunset lines were critical for SF State students.

Jordan Ween requested that remote public comment via call-in continue post-pandemic.

Edward Mason shared his experience calling into a SFMTA virtual open house for Sanchez Slow Street and requested that the agency only use local phone numbers.

Hayden Miller acknowledged that Free Muni for Youth is moving forward on August 15 and suggested a joint effort between the SFMTA and the SFUSD.

Herbert Weiner expressed concern about workplace violence and violence prevention, sharing that he sent a letter to Director Tumlin and hoped it was reviewed.

Hal Carter thanked the SFMTA for restoring the M Ocean View and 31 Balboa lines and requested the 28R 19th Avenue, 57 Parkmerced, 18 46th Avenue, 23 Monterey and 43 Masonic lines also be restored.

Luke Bornheimer thanked SFMTA staff for work on the Great Highway pilot and suggested work on increasing safety on Lincoln Way and the Great Highway where users are entering the promenade space.

David Pilpel highlighted a Board of Supervisors resolution and SFMTA response, hoping that the next response be timelier. He also agreed with previous comments about continuing virtual public meetings.

13. Presentation and discussion regarding a transit fleet update. (Explanatory documents include a slide presentation.)

Julie Kirschbaum, Director of Transit, presented the item.

PUBLIC COMMENT:

Hayden Miller was glad that the agency is looking to expand the double ended vintage street cars fleet.

Cat Carter expressed excitement to see new light rail vehicles (LRVs) on their way, would also like to see better customer facing improvements especially for those with disabilities, and expressed support to procure more vehicles.

Aleta Dupree looked forward to the new LRVs and proposed more side-facing seating near the doors. She also supported battery powered busses in SF and appreciated repairs being done in-house.

David Pilpel questioned why reliability was trending down since December and asked about quarterly Prop E reports, suggesting those be brought back.

14. Presentation and discussion regarding transit service restoration. (Explanatory documents include a slide presentation.)

Jeffrey Tumlin, Director of Transportation, and Julie Kirschbaum, Director of Transit, presented the item.

PUBLIC COMMENT:

Aleta Dupree shared that the SFMTA needs to serve disabled riders and advocated for more service, not less. She also shared that a tax increase may be needed to balance the budget.

Herbert Weiner expressed concern over the expected distance for riders to walk to a bus stop and suggested the agency meet with passengers.

Zack Lipton shared he was in favor of restoring 100% of service hours as is possible and pointed out conflicting items on the agenda.

Alfreda O'Neil understood the challenges and expressed concern about the 52 Excelsior motor noise through the neighborhood.

Simon Deloria thanked staff for bringing back the 31 Balboa line expressing that the line will serve neighborhoods that need it the most.

Eric Rozel thanked the agency for reinstating the 31 Balboa, M Ocean View and other vital lines. He requested that all service be restored to pre-pandemic levels, the agency conduct robust community engagement, and work with community to find lasting solutions to the budget deficit.

Cat Carter expressed excitement for the return of the 31 Balboa and M Ocean View lines. She thanked staff for their iterative response and urged the SFMTA to be bold in restoring service and access.

Ron Catal urged the SFMTA to consider the feasibility of running more service and that it doesn't have to be 100% of pre-pandemic service.

Barry Taranto agreed with the agency regarding downtown service and questioned the reluctance to bringing back the 31 Balboa line, suggesting it would be better to improve service during peak hours and rely on taxis for late hours.

Nishant Kheterpal suggested that the SFMTA should restore ring routes, evening service past midnight, and more parallel service routes.

Chris Arvin appreciated that the agency was being responsive to bringing back late-night service and the 31 Balboa line, and also urged the SFMTA to push all major routes as soon as possible.

Hayden Miller recognized the efforts made thanks to community advocacy and expressed concern over cutting community and parallel routes, urging the SFMTA to keep the lines.

Lavender shared her experience of trying to get from the Golden Gate Heights neighborhood to UCSF Mount Zion, urging the SFMTA to restore the 6 Haight/Parnassus line to full-service.

David Pilpel appreciated the explanation of the transit death spiral scenario and agreed that there were policy trade-offs. He shared that there needs to be meaningful public outreach and offered to meet with staff.

15. Presentation and discussion regarding SFMTA Security, Investigations & Enforcement and Muni Security Incidents. (Explanatory documents include a slide presentation.)

Kimberly Burrus, Chief Security Officer, presented the item.

PUBLIC COMMENT:

Eva Poon expressed appreciation for the presentation and concern about Asian American safety, urging the SFMTA to do more to prevent harassment and attacks.

Winnie Yu discussed senior safety needs and requested installation of security cameras and highly visible signate on buses and landscape improvements on streets to help deter and prevent crime.

Thea Selby commended the SFMTA for moving from enforcement to compliance as a way of dealing with safety issues and was glad to hear that incidents have gone down.

Hayden Miller observed that location of incidents tends to happen at terminal locations and shared his thoughts about the perception of safety.

Raul Maldonado expressed support for future investments in security and opportunities for community ambassadors and looked forward to the next steps.

Barry Taranto expressed concern for safety on buses and bus stops, also sharing about taxi driver safety at cab stands.

Sarah Wan expressed safety and language concerns for students going to and from school. She also expressed concern for the elderly and urged the SFMTA to meet with community groups to ensure the safety of the Asian American community.

16. Presentation and discussion regarding the Vision Zero Action Strategy Update. (Explanatory documents include a slide presentation.)

Ryan Reeves, Sr. Transportation Planner/Vision Zero Program Lead, presented the item.

PUBLIC COMMENT:

Eric Rozel urged the SFMTA to take bold and immediate action to create safe streets for all, including quick-builds, safe crossings for seniors, youth, and all other pedestrians.

Brian Haagsman shared that more is needed in the final strategy including more urgency and a more outcomes focused approach. He urged the SFMTA to find a way to do more.

Zack Lipton appreciated staff's efforts, but shared it wasn't enough, and asked the Board to co commit to more aggressive and immediate action for safe streets.

Richard Rothman shared that there needs to be a culture shift in the Streets Division, to throw away the rule book and listen to the community because they know what's best.

Yan Chang expressed worry about street safety for her son and urged the SFMTA to take Vision Zero seriously, making real changes to slow our streets.

Kimberly urged the SFMTA for a more aggressive Vision Zero Action Strategy and to focus on solutions that can slow our streets and keep all of us safe in the crosswalks.

Marta Lindsey expressed appreciation to SFMTA staff, sharing that the solutions have to happen at the scale of the problem we are facing, and urging the Board to go as big as possible with the best solutions.

Marilyn Kriegel thanked the SFMTA for improvements made to Geary Boulevard and expressed concern regarding pedestrian safety, urging the Board to put people first.

Fennel Doyle shared her experience of being hit by a high-speed driver on Fulton Street expressing her disgust and urging the Board to do more, faster.

Charlie expressed frustration with Vision Zero and highlighted the closure of Upper Great Highway as an example of when Vision Zero does not support the agenda.

Elizabeth Catalano shared her experience of being hit by a car on Monterey Boulevard, commended staff for their work, but urged the Board to be much more aggressive compared to what is proposed.

Shannon discussed high-injury network streets, sharing that the solutions being proposed are too modest while empowering staff to make them feel bold and willing to prioritize pedestrians over traffic and parking spaces.

Judi shared that the Slow Streets in the Sunset neighborhood are empty and need to reopen and expressed concern about closure of the Upper Great Highway and removing free parking in Golden Gate Park.

Anonymous shared that Vision Zero would be more protected if the Great Highway was reopened and expressed concern for traffic congestion caused by the closure.

Rick Girling shared his experience as a result of an incident with a Muni bus and urged the SFMTA to take bold action to redesign transportation infrastructure.

Karen Rose thanked the Board for the time and urged the Board for the most aggressive, boldest strategy to end traffic fatalities and severe injuries by 2024.

Julie Nicolson shared her experience of being struck by a driver and encouraged the Board to adopt the most ambitious Vision Zero Action Strategy and to put every resource toward life-saving solutions.

Dave Alexander thanked staff for their work but urged them to do more and to look to other cities who are also trying to prevent reckless driving.

Anonymous shared that for too long the City prioritized driver speed at the expense of driver safety and urged the SFMTA to slow down the streets.

Barry Taranto suggested holding a joint meeting with the Police Commission and staff to discuss the issues and further commented on right turn lights in the Tenderloin neighborhood.

Leah Hickey expressed concern for pedestrians near her work and suggested doing an evaluation of the medical center so improvements could be made.

Lisa Church urged the Board to take more aggressive action on Vision Zero and on Slow Streets while also expressing concern for street safety.

Raul Maldonado urged the SFMTA to be more aggressive with the strategy and thanked the board for listening to everyone and their stories.

Anonymous shared that the SFMTA approach must radically change and that we've made zero progress with Vision Zero.

Malcom Jaramillo urged the SFMTA to be more aggressive and focused on solutions that can quickly slow the streets and keep people safe.

Caroline Aires shared her experience living near Caesar Chavez Street and urged San Francisco to take bold actions for safe streets so we can make progress.

Ruth Malone urged the Board for very strong implementation of Vision Zero and shared her experience of living car-free, biking, or taking public transit when getting around town.

Jay Bean shared that people need to be held accountable, including drivers, and suggested that the SFMTA collaborate with the SFPD and other city agencies.

Luke Bornheimer urged the Board to push and encourage the Vision Zero team to go back and make the Action Strategy bolder to help get to zero fatalities as soon as possible, ideally before 2024.

17. Presentation and discussion regarding a fiscal and management update including the 2020 State of Good Repair Report. (Explanatory documents include a staff report, report, and slide presentation.)

Jonathan Rewers, Acting Chief Financial Officer, and Jerad Weiner, Asset Management Unit Manager, presented the item.

PUBLIC COMMENT:

David Pilpel identified a numbering error in the staff report, commented on staff report and slide presentation content, and found that the appendix slides at the end of the slide presentations very helpful.

18. Presentation and discussion regarding ConnectSF Investment Strategies. (Explanatory documents include a slide presentation.)

The item was continued to a future date.

PUBLIC COMMENT:

David Pilpel shared that he was on the SF Futures Task Force but had not heard back and will follow up with staff regarding strategy.

Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
