David Pilpel stated that he will follow up directly with staff on some items of the plan. He believes that it's important to connect the plan elements accountability with other agency efforts. He doesn't believe that the strategic plan exists in a vacuum. Connecting other efforts together will reinforce each other. Fundamentally, he is not sure that the board and staff understand the deep mistrust there is with the public and frontline staff on a variety of issues. Success in the future requires rebuilding that trust.

6. Presentation, discussion and possible action regarding the 2021 SFMTA 20 Year Capital Plan.

Darryl Yip, Transportation Planner, Policy and Long-Range Planning, Streets Division, presented the report.

PUBLIC COMMENT:

David Pilpel stated that he supports the restore program. He opposes the expand projects. He believes in maintaining existing assets for a better state of good repair. It's hard to justify the listed projects and it's very speculative that a demand warrants expansion. If that is basis for a new revenue measure, the measure would fail.
