

# What You Need to Know about Residential Permit Parking

- When eligible, residents may apply in person or by mail with the following information:
  - a) Current California DMV vehicle registration <u>must be in the applicant's name at permit address</u>.
  - b) Copy of vehicle insurance documents in the applicant's name and address.
  - c) A check made payable to: San Francisco Municipal Transportation Agency (\$110 annual, \$55 for 6 months validity or less).
  - d) The completed RPP application, which will be mailed to you when you become eligible.
- All delinquent parking citations must be paid prior to permit being issued.
- **Permits must be applied** to either the **left rear bumper** or lower **left rear window** (outside only), plainly visible for the SFMTA Parking Control Officer's inspection. Permits are valid only on the vehicle with the license plate number indicated on the permit.
- The permit exempts the vehicle from RPP time limit restrictions **only**. Street cleaning, red zone, white zone and all other parking restrictions, including parking meters, still apply.
- **Business establishments** in this RPP Area are eligible for one permit per official mailing address. A copy of the current property title/lease and current Business Tax Registration or Tax Exempt Certificate is required. Up to three additional permits for vehicles with commercial license plates registered to the business address are also available for delivery vehicles.
- **Caregivers.** RPP permits are also available for medical and child caregivers, students and active military personnel. Special application requirements apply.
- **Temporary permits.** Up to 20 1-day permits are available for guests and may be purchased in advance for use as needed. Longer term temporary permits for 2, 4, 6 or 8 weeks may also be available.

(Approximately three months after approval of the proposed RPP Area by the SFMTA Board of Directors, residents will receive applications to purchase a permit for their vehicles. It will take about three months to install all the RPP signs and print and deliver the RPP decals.)

# Frequently Asked Questions about RPP

### What if I live just outside the boundary of Area Q. How can I get a permit?

The establishment of a new RPP Area or the extension of an existing Area is initiated by residents. If you live on a block outside any existing RPP Area, you, together with your neighbors, may petition the SFMTA to have your block included in the Area closest to your residence. The petition must have signatures from at least 51% of the residential units on the block. Once your block is added to an RPP area, you are eligible to purchase a permit.

# What if I do not own a car, but rent one for a few days or have visitors?

RPP parking regulations are only in effect Monday through Friday, from 8am to 6pm or 8pm. Visitors do not need a permit to park in the evening or on weekends. If you need to rent a car or have visitors during the work week, Monday through Friday, between 8am and 6pm, you may purchase up to 20 low cost 1-day temporary permits per year. In addition, if you are a new resident, or living here temporarily, you may purchase 2, 4, 6 or 8-week temporary permits.

### I own a business in the area. Can I get a permit?

An individual who owns or leases commercial property within an RPP area is eligible to purchase one permit. The permit is issued to the individual holding the lease. To purchase a permit, the business owner must show a current property lease or deed, a current business tax certificate and a current vehicle registration. A business address is eligible for only one permit. In addition, up to 3 permits may be issued for commercial delivery vehicles. Vehicles must display a commercial license plate and be registered to the business at the business address in the RPP area. Businesses wishing to purchase a permit are strongly encouraged to call the Customer Service Center at 701-3000 to more fully understand the requirements for obtaining a permit.

#### I have care takers come to my home every day. Can I get a permit for them?

There are permits available for both child care providers and for medical care providers. For Medical care providers, the resident is issued a transferrable permit that can be used by any medical care provider authorized by the residents licensed physician. The resident can be issued a transferrable child care permit up submittal of a petition signed by the neighbors along with a copy of the child's birth certificate.

# If approved, when will RPP go into effect?

Once the SFMTA Board approves the establishment of a new RPP Area, it takes up to three months to install the signs and print the new decals. Residents will receive letters informing them of when RPP will become effective, along with an application for a permit.

# How do I purchase a permit?

Once eligible, you may purchase your permit in one of two ways, by mail or in-person. If you choose to order your permit by mail, you can download the application from the SFMTA website, complete the application and send it along with copies of your vehicle registration and insurance and the fee to Customer Service Center at 11 So Van Ness. You may also go directly to 11 So. Van Ness, with the proper documentation and pay for your permit there.



# How is RPP enforced?

PCOs patrol RPP areas regularly to ensure residents have access to on-street parking in their neighborhood. One Parking Control Officer is, usually, assigned to a residential area. For large areas it may be more than one. In order to best meet the needs of the community, PCOs are deployed by RPP Area a follow a prioritized procedure. RPP is enforced Mon thru Fri, deploying PCOs from 630 am, 0800am and the 100pm watches.

#### How far do I need to move my car so as not to get a ticket?

In permit areas you must move your vehicle after the posted time limit (2 hours) if you don't have a permit. The law requires you to move one block away or at least one-tenth (1/10) of a mile—about 500 feet. Do not drive around and then park in the same block, or you can be ticketed! Not all vehicle tires are marked with chalk, so don't assume that not having a chalk mark means your car has not been checked. Now, most PCOs have handheld electronic tracking computers that will log your license plate as being parked on a specific block. When the officer returns to the block in 2 hours, if you are still parked anywhere on that block, you will get a ticket.

### Can RPP regulations be changed?

After a new RPP Area is established, the specific days and times of restricted parking may be changed. For instance, if residents want parking restrictions to extend into the evening hours, up until 9 pm or to the weekend, mostly Saturdays, they may petition the SFMTA to make these changes. As with any petition to modify traffic regulations, the petition must have signatures from a majority of the households on the blocks that want the change. In addition, any block within an existing RPP Area may petition the SFMTA to have RPP eligibility on their block rescinded. The petition must have signatures from a majority of the households on the block that desires the change. Most requests to modify RPP Area restrictions take about 3 months to be processed.
