





FOR PROPOSED PARKING & TRAFFIC CHANGES

Pursuant to SFMTA Order No. 5429 adopted June 9, 2015, the San Francisco Municipal Transportation Agency will hold a public hearing to solicit public input on the following proposed changes. The hearing will be held as follows:

REVOKE – BLUE ZONE

1301 7th Avenue, west side, from 8 feet to 35 feet south of Irving Street (27-foot zone).

ESTABLISH - BLUE ZONE

599 Irving Street, south side, from 7th Avenue to 20 feet easterly (20-foot zone).

ESTABLISH - RED ZONE

"500" Dolores Street, west side, from 18th Street to 31 feet southerly.

ESTABLISH – BLUE ZONE

"500" Dolores Street, west side, from 31 feet to 51 feet south of 18th Street (20-foot zone).

ESTABLISH – PASSENGER LOADING ZONE, 8:30-9:30 AM; 11:30-1:30 PM; and 3:30-5 PM, MONDAY-FRIDAY

401 Euclid Avenue, south side, from the west crosswalk at Heather Avenue to 24 feet easterly, and from 7 feet to 25 feet east of the east crosswalk (42 feet total).

RESCIND – SHORT-TERM PARKING METER, 30-MINUTE LIMIT

ESTABLISH – SHORT-TERM PARKING METER, 15-MINUTE LIMIT

"391" 19th Avenue, west side, from 56 feet to 99 feet north of Geary Boulevard (at parking meters #391 and #393).

RESCIND – SHORT-TERM PARKING METER, 30-MINUTE LIMIT

2310 Fillmore Street, east side, from 28 feet to 72 feet north of Clay Street (at parking meters #2306 and #2308).

ESTABLISH – SHORT-TERM PARKING METER, 15-MINUTE LIMIT

2310 Fillmore Street, east side, from 50 feet to 94 feet north of Clay Street (at parking meters #2308 and #2310).

RESCIND - METERED YELLOW ZONE, 9 AM-6 PM, MONDAY THROUGH SATURDAY

1245 South Van Ness Avenue, east side, from 75 feet to 141 feet north of the south property line (at parking meters #1229, #1231, and #1233).

ESTABLISH – PASSENGER LOADING ZONE (DURING POSTED SERVICES)

501 Fulton Street, south side, from 13 feet to 31 feet west of Octavia Street (18-foot zone).

ESTABLISH – SHORT-TERM PARKING METER, 15-MINUTE LIMIT

301 Folsom Street, south side, from 45 feet to 65 feet west of Beale Street (at parking meter #305).

ESTABLISH – SHORT-TERM PARKING METER, 30-MINUTE LIMIT

284 Noe Street, west side, from 48 feet to 70 feet north of Market Street (at parking meter #266).

ESTABLISH – PASSENGER LOADING ZONE, 8AM-9AM, 12:30PM-1:30PM, AND 4:30PM-6PM, MONDAY THROUGH FRIDAY

1060 Tennessee Street, west side, from 7 feet to 37 feet north of the south property line (30-foot zone).
