Background

The SFMTA implemented the *Page Street Bikeway Improvements Pilot* in spring 2020, which included restrictions on freeway-bound traffic and bikeway upgrades on Page Street between Webster and Gough streets, just days before the COVID-19 shelter-in-place began. Weeks later, the SFMTA separately developed the <u>Slow Streets program</u> to provide folks with an opportunity to make socially distanced trips and get exercise during the pandemic. The Page Slow Street extended similar treatments to those included with the Page Street Bikeway Improvements Pilot westward to Stanyan Street.

After over two years of outreach and evaluation, the SFMTA recommends removing the temporary emergency approvals for existing through-traffic restrictions and adding targeted upgrades at intersections not addressed with the initial implementation. Establishing this post-pandemic roadway configuration would kick off further outreach to neighborhood and community groups to consider other changes on and adjacent to Page Street.





Page Street traffic circulation – Existing and proposed measures








