BRIEF DESCRIPTION:

Approving parking regulations and amending Transportation Code, Division II regarding permit parking and establishing commercial loading, passenger loading, short term parking, and blue zone parking on Grove Street, Van Ness Avenue, and Dr. Carlton B. Goodlett Place. Both the accessibility improvements and passenger and commercial loading for a new development require changes to existing permit parking.

SUMMARY:

- The proposed parking modifications aim to advance two goals: to improve accessibility near City Hall and accommodate passenger and commercial loading needs for a new development in the same vicinity.
- City Hall Building Management has worked with SFMTA staff to relocate permit parking spaces to meet these needs.
- SFMTA Accessible Services and the Mayor's Office on Disability propose the addition of blue and green zones to improve accessibility.
- The San Francisco Planning Department's Street Design Advisory Team, in coordination with the developer, has assessed and identified loading zone requirements for the new housing development at Van Ness Avenue and Grove Street.
- The SFMTA, under authority delegated by the Planning Department, has determined that the proposed regulations are categorically exempt from the California Environmental Quality Act (CEQA).
- The proposed action is the Approval Action as defined by the S. F. Administrative Code Chapter 31.

PURPOSE

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

SFMTA Strategic Plan

Goal 4: Make streets safer for everyone.

Transit First Principles

To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.

DESCRIPTION

The proposed parking modifications aim to advance two goals: to improve accessibility near City Hall and to accommodate passenger and commercial loading needs for a new development in the same vicinity. For the first goal, the Mayor's Office on Disability, in collaboration with SFMTA Accessible Services and Parking and Curb Management, has identified opportunities to enhance accessibility in the vicinity of City Hall. This effort includes the proposal to install new accessible parking stalls and a short-term parking stall to better serve the needs of the community.

For the second goal related to a nearby development, the San Francisco Planning Department's Street Design Advisory Team, working in coordination with the developer of The Kelsey Civic Center housing project, determined loading zone needs for the new development located at Van Ness Avenue and Grove Street. The Kelsey Civic Center will provide 112 inclusive housing units for individuals with and without disabilities across a range of income levels.

To support both improved accessibility around City Hall and loading access for the new development, SFMTA staff recommends that the SFMTA Board approve the proposed parking and curb use modifications listed in Items A through I below:

 A. RESCIND – PERMIT PARKING ONLY, AT ALL TIMES ESTABLISH – BLUE ZONE, ACCESSIBLE PARKING, AT ALL TIMES, Dr. Carlton B. Goodlett Place, west side, from 20 feet to 41 feet north of Grove Street (Permit Space #49, 21-foot zone)

- B. RESCIND PERMIT PARKING ONLY, 6 AM TO 7 PM, MONDAY THROUGH FRIDAY, ESTABLISH – GREEN ZONE, SHORT-TERM PARKING, 15-MINUTE TIME LIMIT, 6 AM TO 7 PM, MONDAY THROUGH SATURDAY, Grove Street, north side, from 120 feet to 130 feet west of Dr. Carlton B. Goodlett Place (Permit Space #75, 10-foot zone)
- C. RESCIND PERMIT PARKING ONLY, 6 AM TO 7 PM, MONDAY THROUGH FRIDAY, ESTABLISH – BLUE ZONE, ACCESSIBLE PARKING, AT ALL TIMES, Grove Street, south side, from 25 feet to 48 feet west of Dr. Carlton B. Goodlett Place (Permit Space #14, 23-foot zone)
- D. ESTABLISH YELLOW METERED ZONE, SIX-WHEEL COMMERCIAL LOADING, 30-MINUTE TIME LIMIT, AT ALL TIMES, Grove Street, north side, from 37 feet to 107 feet east of Van Ness Avenue (70-foot zone)
- E. RESCIND BLUE ZONE, ACCESSIBLE PARKING, AT ALL TIMES, Van Ness Avenue, east side, from 17 feet to 36 feet north of Dr. Tom Waddell Place (19-foot zone)
- F. ESTABLISH WHITE ZONE, ACCESSIBLE PASSENGER LOADING, 5-MINUTE TIME LIMIT, AT ALL TIMES, Van Ness Avenue, east side, from 10 feet to 67 feet north of Dr. Tom Waddell Place (57-foot zone)
- G. RESCIND YELLOW METERED ZONE, COMMERCIAL LOADING, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY, Grove Street, south side, from 92 feet to 114 feet east of Van Ness Avenue (22-foot zone)
- H. ESTABLISH YELLOW METERED ZONE, SIX-WHEEL COMMERCIAL LOADING, 30-MINUTE TIME LIMIT, 8 AM TO 6 PM, MONDAY THROUGH SATURDAY, Grove Street, south side, from 92 feet to 117 feet east of Van Ness Avenue (25-foot zone)
- I. RESCIND PERMIT PARKING ONLY, 6 AM TO 7 PM, MONDAY THROUGH FRIDAY, ESTABLISH – WHITE ZONE, ACCESSIBLE PASSENGER LOADING, 5-MINUTE TIME LIMIT, AT ALL TIMES, Grove street, south side, from 117 feet to 177 feet east of Van Ness Avenue (Permit Spaces #93, #92, & #91, 60-foot zone)

STAKEHOLDER ENGAGEMENT

The Mayor's Office on Disability, SFMTA's Accessible Services, and Parking and Curb Management propose measures to enhance accessibility near City Hall. City Hall Building Management acknowledges that SFMTA plans to convert permit spaces located on the west side of Dr. Carlton B. Goodlett Place, north of Grove Street and on the south side of Grove Street, west of Dr. Carlton B. Goodlett Place to ADA parking, and a permit space located on the north

side of Grove Street, west of Dr. Carlton B. Goodlett Place into short-term parking. Three replacement permit spaces are to be added to the designated areas within the Civic Center Garage.

Additionally, the Street Design Advisory Team has met with the developers of the Kelsey Civic Center to determine their loading needs. City Hall Building Management acknowledges that SFMTA plans to convert permit spaces #91, #92, and #93 into accessible passenger loading, and commercial loading in the coming months. Replacement permit spaces have been added to the designated areas within the Civic Center Garage.

ALTERNATIVES CONSIDERED

Staff considered the "no action" alternative but rejected it to support accessibility and loading demands.

FUNDING IMPACT

There is no expected impact to SFMTA.

ENVIRONMENTAL REVIEW

The proposed parking modifications are subject to the California Environmental Quality Act (CEQA). CEQA provides a categorical exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities pursuant to Title 14 of the California Code of Regulations Section 15301.

On May 2, 2025, the SFMTA, under authority delegated by the Planning Department, determined that the proposed parking modifications (Case No. 2025-003182ENV) are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301.

The proposed action is the Approval Action as defined by the San Francisco Administrative Code Chapter 31.

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Article 800 of Division II of the Transportation Code is hereby amended by revising Section 801, to read as follows:
