## **BRIEF DESCRIPTION:**

Approving various routine parking and traffic modifications.

## **SUMMARY:**

- The SFMTA Board of Directors has authority to adopt parking and traffic regulations changes.
- Taxis are not exempt from any of these regulations.
- The proposed parking and traffic modifications have been reviewed pursuant to the California Environmental Quality Act (CEQA).
- The proposed action is the Approval Action for Items A-O as defined by S.F. Administrative Code Chapter 31.

#### **PURPOSE**

To approve various routine parking and traffic modifications.

## STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES:

- 4. Make streets safer for everyone.
- 5. Deliver reliable and equitable transportation services.
- 6. Eliminate pollution and greenhouse gas emissions by increasing use of transit, walking, and bicycling.

This action supports the following SFMTA Transit First Policy Principles:

- 1. To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.
- 2. Public transit, including taxis and vanpools, is an economically and environmentally sound alternative to transportation by individual automobiles. Within San Francisco, travel by public transit, by bicycle and on foot must be an attractive alternative to travel by private automobile.
- 3. Decisions regarding the use of limited public street and sidewalk space shall encourage the use of public rights of way by pedestrians, bicyclists, and public transit, and shall strive to reduce traffic and improve public health and safety.

## **ITEMS**

The following items were considered at Public Hearing on June 6, 2025

- A. ESTABLISH RESIDENTIAL PERMIT PARKING AREA A (Eligibility only, no signs), 1150 Francisco Street (Requested by school).
  - Modification A would extend RPP Area A eligibility to this parcel and allow the teachers to purchase parking permits for their vehicle to park within Area A.
- B. ESTABLISH RESIDENTIAL PERMIT PARKING AREA X (Eligibility only, no signs), Rhode Island Street, both sides, between 16th Street and 17th Street (Requested by residents).
  - Modification B would extend RPP Area X to this block facing restricted street parking and allow the residents to purchase parking permits for their vehicle to park within Area X
- C. ESTABLISH RESIDENTIAL PERMIT PARKING AREA R (Eligibility only, no signs), Eddy Street, both sides, between Franklin Street and Van Ness Avenue (Requested by residents).

Modification C would extend RPP Area R (eligibility only, no signs) to this block facing restricted street parking and allow the residents to purchase parking permits for their vehicle to park within Area R.

- D. ESTABLISH RESIDENTIAL PERMIT PARKING AREA U (Eligibility only, no signs), Bryant Street between 2nd Street and 3rd Street, both sides (Requested by residents).
  - Modification D would extend RPP Area U to this block facing restricted street parking and allow the residents to purchase parking permits for their vehicle to park within Area U (excluding parcels already granted eligibility)
- E. ESTABLISH GENERAL METERED PARKING, NO TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY, Font Boulevard, north and south sides, between Tapia Drive/Arballo Drive and Lake Merced Boulevard (Requested by SFMTA).
- F. RESCIND RESIDENTIAL PERMIT PARKING AREA E, ESTABLISH GENERAL METERED PARKING, NO TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY, Arballo Drive, west side, between Font Boulevard and Vidal Drive (Requested by SFMTA).
  - Modifications E–F would convert existing unregulated blocks to metered parking to provide consistent parking regulations and help increase parking turnover and availability.
- G. RESCIND PERPENDICULAR PARKING, ESTABLISH PARALLEL PARKING, Connecticut Street, west side, from 129 feet to 165 feet south of 26th Street (Requested by SFPW–BSM) (Requested by SFMTA).
  - Modification G would convert perpendicular parking to parallel parking due to sidewalk construction at 1920 Cesar Chavez Street.

The following items were considered at Public Hearing on June 20, 2025

- H. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME, 47th Avenue, east side, from Vicente Street to 35 feet southerly (Requested by SFMTA).
  - Modification H would restrict parking across residential driveways to improve Muni turning clearance.
- I. RESCIND METERED MOTORCYCLE PARKING, ESTABLISH GENERAL METERED PARKING, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY, Drumm Street, west side, from 118 feet to 260 feet north of Clay Street (Requested by SFMTA).
  - Modification I would convert underutilized motorcycle parking on the west side of the 200 block of Drumm Street to standard metered parallel parking (7 stalls), with 28 metered motorcycle stalls retained.

- J. RESCIND TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, 29th Street, north side, from Dolores Street to 17 feet easterly (Requested by SFMTA).
- K. ESTABLISH TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, 29th Street, south side, from 13 feet to 30 feet east of Dolores Street (Requested by SFMTA).
- L. ESTABLISH RED ZONE, 29th Street, north side, from Dolores Street to 20 feet easterly (Requested by SFMTA).
- M. RESCIND TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Belcher Street, west side, from 14th Street to 20 feet northerly (Requested by SFMTA).
- N. ESTABLISH TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Belcher Street, west side, from 10 feet to 28 feet north of 14th Street (Requested by SFMTA).
- O. ESTABLISH RED ZONE, Belcher Street, west side, from 14th Street to 10 feet northerly (Requested by SFMTA).

Modifications I–O would rescind and re-establish existing on-street car share parking spaces to insert proper intersection daylighting, per Assembly Bill 413.

## **ENVIRONMENTAL REVIEW**

The proposed traffic and parking modifications are subject to the California Environmental Quality Act (CEQA). CEQA provides a statutory exemption from environmental review under Public Resources Code Section 21080.25 for pedestrian and bicycle facilities that improve safety, access, or mobility, including new facilities within the public right-of-way; projects that improve customer information and wayfinding for transit riders, bicyclists, or pedestrians within the public right-of-way; transit prioritization projects; and the maintenance, repair, relocation, replacement, or removal of any utility infrastructure associated with the specified project types.

CEQA provides a categorical exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities pursuant to Title 14 of the California Code of Regulations Section 15301.

The SFMTA, under authority delegated by the San Francisco Planning Department, has determined that the proposed parking and traffic modifications in Items A-F (Case No. 2025-004825ENV, May 29, 2025), Item G (Case No. 2024-010750ENV, December 2, 2024), Items H-I (Case No. 2025-005434ENV, June 6, 2025), and Items J-O (Case No. 2017-005615ENV, June 23, 2017) are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301.

The proposed action is the Approval Action for Items A-O as defined by San Francisco

Administrative Code Chapter 31.

- B. ESTABLISH RESIDENTIAL PERMIT PARKING AREA X, Rhode Island Street, both sides, between 16th Street and 17th Street.
- C. ESTABLISH RESIDENTIAL PERMIT PARKING AREA R, Eddy Street, both sides, between Franklin Street and Van Ness Avenue.
- D. ESTABLISH RESIDENTIAL PERMIT PARKING AREA U, Bryant Street between 2nd Street and 3rd Street, both sides.
- E. ESTABLISH GENERAL METERED PARKING, NO TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY, Font Boulevard, north and south sides, between Tapia Drive/Arballo Drive and Lake Merced Boulevard.
- F. RESCIND RESIDENTIAL PERMIT PARKING AREA E, ESTABLISH GENERAL METERED PARKING, NO TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY, Arballo Drive, west side, between Font Boulevard and Vidal Drive.
- G. RESCIND PERPENDICULAR PARKING, ESTABLISH PARALLEL PARKING, Connecticut Street, west side, from 129 feet to 165 feet south of 26th Street, and,
- H. ESTABLISH TOW-AWAY, NO STOPPING ANY TIME, 47th Avenue, east side, from Vicente Street to 35 feet southerly.
- I. RESCIND METERED MOTORCYCLE PARKING, ESTABLISH GENERAL METERED PARKING, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY, Drumm Street, west side, from 118 feet to 260 feet north of Clay Street.
- J. RESCIND TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, 29th Street, north side, from Dolores Street to 17 feet easterly.
- K. ESTABLISH TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, 29th Street, south side, from 13 feet to 30 feet east of Dolores Street.
- L. ESTABLISH RED ZONE, 29th Street, north side, from Dolores Street to 20 feet easterly.
- M. RESCIND TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Belcher Street, west side, from 14th Street to 20 feet northerly.
- N. ESTABLISH TOW-AWAY, NO STOPPING, EXCEPT PERMITTED CAR SHARE, Belcher Street, west side, from 10 feet to 28 feet north of 14th Street.
- O. ESTABLISH RED ZONE, Belcher Street, west side, from 14th Street to 10 feet northerly, and,

WHEREAS, The proposed traffic and parking modifications are subject to the California Environmental Quality Act (CEQA); CEQA provides a statutory exemption from environmental review under Public Resources Code Section 21080.25 for pedestrian and bicycle facilities that improve safety, access, or mobility, including new facilities within the public right-of-way;
