4. Public Comment

Edward Mason stated that in the Noe Valley area most of the corporate commuter buses stop at unauthorized corners, specifically at 24th and Sanchez instead of Noe. They are making illegal right turns from the center lane. This has been ongoing since August and there is no enforcement. The SFMTA's lack of data collection at unauthorized locations doesn't allow the Agency to collect fees.

Jerry Lee requested more up-to-date information on the economic impact of service delays. He also requested an update on the shuttle bus program at the October PAG meeting.

PUBLIC COMMENT:

Edward Mason discussed the wellness program and hopes the SFMTA can pay employees to get well similar to a program IBM had for their employees. This is a mechanism to reduce the cost of health care and an incentive to stop smoking and reduce body mass index.
