5. Report of the Chair (For discussion only)

None.

6. Public Comment:

Edward Mason discussed corporate commuter buses in the Noe Valley neighborhood. He questioned why operators were choosing the stops and routes and the use of white zones. There are continuing problems on Guerrero, a weight restricted street and on the 48 line. He has spoken with staff about the issues.

REGULAR CALENDAR

7. Presentation, discussion and possible action regarding the status of the taxicab industry in San Francisco. (Kate Toran, Director, Taxis and Accessible Services)

Kate Toran discussed the mission of the Taxi and Accessible Services Division and regulation of the taxi industry. There are a lot of regulations regarding public safety including insurance, driver training and complaint investigations, clean air and equipment requirements. Taxis are an important part of the paratransit program. Ms. Toran discussed the recent development of transportation network companies and their impact on the taxi industry. The Transportation Network Companies (TNC's) are regulated by the California Public Utilities Commission (CPUC). San Francisco and the CPUC have very different and misaligned regulatory frameworks. Wheelchair pickups by ramped taxis have declined which is a result of the TNC's. The SFMTA has provided economic relief to the taxi industry and is reviewing all regulations to see where additional flexibility could be found. The taxi industry is working to improve service and get on an app. Flywheel has approximately 80% of the taxi fleet. Taxi drivers are improving pick-up times and more drivers are accepting credit cards. A new taxi driver workers union was recently ratified. There is a data management system to better manage the taxi industry. There is increased enforcement for TNC's when they park in bus zones or at taxi stands. Ms. Toran is looking to establish a broad-based taxi task force and improve outreach to the industry.

Dorris Vincent arrived.

No public comment.

8. Presentation, discussion and possible action regarding the Short Range Transit Plan. (Darton Ito, Manager, Long Range Planning)

Darton Ito provided an overview of the plan. The Metropolitan Transportation Commission requires that transit agencies prepare a document describing operating, service, and capital improvement plans for the next 10-20 years. The plan will review service standards, operating budget and needs and what capital improvement investments will be made. The plan will also discuss expansion projects such as Van Ness Bus Rapid Transit and the Central Subway project. Staff has used existing reference documents to create the plan. The draft report will be sent to the CAC in December. The plan will be submitted to the Board for adoption in February.

Chairman Weaver referred the draft Short Range Transit Plan to the January 8 CAC meeting. He also provided a list of existing CAC recommendations for consideration at the January 8 meeting.

PUBLIC COMMENT:

Eric Scott questioned some of the previous CAC recommendations such as the planned reduction of automobiles on Market St. and asked if the recommendations were set in stone.

9. Presentation, discussion and possible action regarding the T-Third Phase 3 study of a possible extension to North Beach and Fisherman's Wharf. (Paul Bignardi, Principal Transit Planner)

Paul Bignardi discussed a "pre-feasibility" study of existing data regarding extending the Central Subway to North Beach and Fisherman's Wharf. The study focused on alignment, grade, construction methods, land use, cost and transit analysis and identified possible corridors for transit. Some of the alignments weren't feasible because of the existence of a large sewer line. The report looked at sea level rise and areas of possible liquefaction and estimated travel time. The report will be presented to the SFMTA Board and the Transportation Authority in December and then would have to go through environmental analysis.

10. Discussion and possible action regarding a recommendation from the Operations and Customer Service Committee (OCSC)

Motion 141002.01

The SFMTA CAC recommends that the SFMTA work with the Metropolitan Transportation Commission to produce Clipper cards of a different color for passes issued under the Free Muni for Youth program, and that if it's not possible to produce such cards, that the SFMTA issue the cards with a sticker indicating they are youth cards, so that adult household members don't inadvertently use them, and so that when adults are caught using such cards, they cannot claim that they didn't know they were using a youth card unlawfully.

Motion 141002.01 was amended as follows:

The SFMTA CAC recommends that the SFMTA work with the Metropolitan Transportation Commission to produce Clipper cards of a different color for passes issued under the Free Muni for Youth program. If it's not possible, then the SFMTA issue the cards with a sticker indicating they are youth cards, to prevent unlawful use of youth passes

Public Comment:

Eric Scott questioned why this was being done at all. There are four classes of cards of which one is a youth card which is visibly different than other cards. There isn't a need to create anything new. If the CAC is going to ask for a card, it should be a lifeline card similar to the Orca card in Seattle.

Motion 141029.1

The SFMTA CAC recommends the following features be incorporated into the LRV4 procurement: the Front End style of Skyline 1 or Presidio, interior color scheme of red or blue, seat location of longitudinal and hand holds with colored stanchions and straps.

Chairman Weaver divided the motion into two separate motions to separate longitudinal seating from the rest of the motion.

Public Comment:

Eric Scott stated that this is an attempt to subvert the public process. He suggested that the CAC wait to get a report on what the survey came up with and then make a decision. If the CAC does submit a recommendation, it should do so in such a way that it's not in conflict with the survey.
