Edward Mason recommended that communicating service delivery changes during the subway evening shutdown be improved. He discussed the N and J lines schedule on the website. Mr. Mason commented that buses continue to violate the vehicle code and Commuter shuttle Bus plan. (Mr. Mason provided a statement for inclusion in the minutes.)

## Statement provided by Mr. Edward Mason:

Edward Mason recommended the process for communicating service delivery changes during the subway evening shutdown be reviewed for improvement.

The N and J initially operated independently per the website. One week later the J and N were combined into one line and the stop locations reverted to the regular stops. The website was no updated for four days until he contacted the MTA.

Several months ago, the capital project presentation explained the technical improvements.

Attendees questioned the service delivery plan which was pending.

Bottom line: the change in stop location delayed him 20 minutes.

Noe Valley corporate commuter bus for July 2015: Twelve observations, six days July 14-24, ten violations – three ton restricted streets, one staging in muni zone and one double parking. The transportation demand partners continue to violate the vehicle code and pilot plan.
