BRIEF DESCRIPTION:

Authorizing the Director of Transportation to execute Amendment No. Two to the Grant and Cooperative Agreement between the SFMTA and the Metropolitan Transportation Commission, to extend the Agreement to June 30, 2017, for the development of encoding data for preencoding of limited use tickets.

SUMMARY:

- Government agencies and non-profit organizations have a need to obtain single-use monthly passes and other fare media to distribute to clients; Clipper® extended use cards do not meet this need.
- The SFMTA entered into a Cooperative Agreement with the Metropolitan Transportation Commission (MTC) in October 2013 for the acquisition of encoding data from Cubic Transportation Systems (Cubic) for the development of pre-encoded limited use tickets with SFMTA fare products, in an amount not to exceed \$380,000.
- The Agreement was amended in May 2015 to extend its duration to June 30, 2016.
- Due to development, testing and contracting delays, an extension is required for one year to complete this project.

PURPOSE

Authorizing the Director of Transportation to execute Amendment No. Two to the Grant and Cooperative Agreement between the SFMTA and the Metropolitan Transportation Commission, to extend the Agreement to June 30, 2017, for the development of encoding data for preencoding of limited use tickets.

GOAL

This item supports the following Strategic Plan Goal.

Goal 3: Improve the environment and quality of life in San Francisco.

DESCRIPTION

When the SFMTA transitioned monthly pass customers to the Clipper® program in 2011, a number of non-profit organizations and government agencies expressed a need to continue to obtain single-use monthly passes for distribution to their clients. The extended use Clipper® card, due to its high manufacturing costs, is not suitable for one-time use. Since that time, the SFMTA began discussions with the Metropolitan Transportation Commission (MTC) and Cubic, the region's Clipper® program vendor, to identify alternatives to meet this need, while continuing to produce a small number of paper monthly passes to this population.

In October 2013, the SFMTA entered into a Cooperative Agreement with MTC to amend its contract with Cubic to allow SFMTA to acquire encoding data and work with a third-party card manufacturer to produce single use pre-encoded limited use tickets. The SFMTA and MTC executed an extension to this Agreement in May 2015. Due to resource constraints and challenges identifying a card manufacturer, an additional one-year extension, through June 17, 2017, is required. This Amendment does not require a change to the amount of the Agreement.

PUBLIC OUTREACH

Staff have worked with MTC on the development of this extension.

ALTERNATIVES CONSIDERED

The SFMTA currently distributes paper monthly "flash" passes to organizations for distribution to its clients. Procuring limited-use tickets is preferred to eliminate duplication and counterfeiting, as well as to provide the SFMTA with usage and ridership data through the Clipper® back-end system.

FUNDING IMPACT

This project is funded through a combination of Federal Transit Administration and Regional Measure 2 funds in an amount not to exceed \$380,000.

ENVIRONMENTAL REVIEW

On May 25, 2016, the SFMTA, under authority delegated by the Planning Department, determined that the Funding Agreement Extension for Pre-Encoded Limited Use Tickets is not defined as a "project" under the California Environmental Quality Act (CEQA) pursuant to Title 14 of the California Code of Regulations Sections 15060(c) and 15378(b).

WHEREAS, In May 2015, the Agreement was extended through June 30, 2016; and

WHEREAS, Due to resource constraints and challenges identifying a card manufacturer, an additional one-year extension is required to complete this project; and

WHEREAS, On May 25, 2016, the SFMTA, under authority delegated by the Planning Department, determined that the Funding Agreement Extension for Pre-Encoded Limited Use Tickets is not defined as a "project" under the California Environmental Quality Act (CEQA) pursuant to Title 14 of the California Code of Regulations Sections 15060(c) and 15378(b); now, therefore be it

AMENDMENT No. 2 TO GRANT AND COOPERATIVE AGREEMENT BETWEEN THE CITY AND COUNTY OF SAN FRANCISCO AND THE METROPOLITAN TRANSPORTATION COMMISSION REGARDING THE EXPENDITURE AND ADMINSITRATION OF GRANT FUNDS FOR THE DEVELOPMENT OF ENCODING DATA TO ALLOW FOR PRE-ENCODING OF LIMITED USE TICKETS

This Amendment, effective as of June 29, 2016, is Amendment No. 2 to the Grant and Cooperative Agreement (Agreement) by and between the City and County of San Francisco, a municipal cooperation, acting by and through its Municipal Transportation Agency (SFMTA), and the Metropolitan Transportation Commission (MTC), effective October 17, 2013 and amended May 15, 2015 (collectively, the "Agreement").

RECITALS

- A. SFMTA and MTC entered into the Agreement so that SFMTA could acquire encoding data that allows SFMTA to procure Clipper[®] limited use tickets that are pre-encoded with several fare products.
- B. The parties desire to amend the Agreement to extend its term.

NOW, THEREFORE, the parties agree to modify the Agreement as follows:

Paragraph I.A (Term) shall be amended to read as follows:

A. This Agreement will commence on the Effective Date and will terminate when all Project-related funds from the Grants have been disbursed and all FTA reporting requirements have been complied with, but in no event later than June 30, 2017.

Except as provided herein, all other terms and conditions of the Agreement remain unchanged and are incorporated by this reference as through set forth in full.
